Adjusts percentages by which Department of Education distributes grant moneys for school food programs.

HB 3211

Validates urban reserves adopted by Metro and Clackamas County.

HB 3431

Extends deadline for owner of Metolius resort site to notify Department of Land Conservation and Development that owner has elected to seek approval of small-scale recreation community.

HB 2894

Authorizes district to approve or veto land division within or adjacent to boundaries of district based on whether land division interferes with operations of district.

HB 3084

HB 3085

Provides that City of Damascus shall surrender its charter, disincorporate and cease to exist.

HB 3086 \*\*

\*\*Subsequent Referral(s) to Revenue Requires City of Damascus to distribute to ad valorem property taxpayers all excess moneys remaining in city funds after satisfying all outstanding legal debts and obligations of city.
