#### Public Hearing

- HB 2289 A  
Creates tax credit for cleanup of brownfield property.
- HB 2734 B  
Authorizes local government to create by ordinance or resolution Land Bank Authority as municipal corporation.

#### Work Session

- HB 3086  
Requires City of Damascus to distribute to ad valorem property taxpayers all excess moneys remaining in city funds after satisfying all outstanding legal debts and obligations of city.
- HB 2083  
Creates exception to five-year ownership requirement for homestead if claimant for deferral moved to homestead from homestead that met five-year ownership requirement.

#### Public Hearing

- HB 2566 A  
Provides that disaster or emergency related work conducted by out-of-state business may not be used as sole basis for determination that business is doing business in state, or that employee has residency or domicile in state.
- HB 2239 A  
Creates income tax credit for hiring of at-risk or disadvantaged youth or youth with intellectual or developmental disability.
- HB 2747 A  
*(Carried Over from 5-4-2015 Meeting)* Increases limitation on subtraction for contribution to college savings network account to amount per designated beneficiary.

HB 3541

*(Carried Over from 5-4-2015 Meeting)* Directs Department of Revenue, in collaboration with Department of Human Services, to establish pilot program for disbursement of installment payments to personal income taxpayers of amounts equal to personal income tax dependent care credits.
