#### Public Hearing and Possible Work Session

HB 2020

Alters definition of "public official."

Prohibits Governor, First Partner, Secretary of State, State Treasurer, Attorney General and Commissioner of Bureau of Labor and Industries from receiving money or other consideration for speaking engagement or presentation.

SB 9

Directs Secretary of State to conduct performance audit of state agency public records retention and disclosure practices, including analysis and recommendations on specified criteria.

SB 292

Repeals duplicative provision regarding conflict of interest for planning commission members.

SB 293

Expands exemption from statutory gift limit to include admission provided to, or cost of food or beverage consumed by, relative of public official who accompanies public official at reception, meal or meeting.

#### Work Session

HB 2252

Establishes requirements under which debt buyer may bring legal action to collect debt.

HB 2995

CARRIED OVER FROM 5/11: Requires transportation network company to maintain insurance policy to cover private passenger motor vehicle when vehicle's registered owner or designated operator actively participates as driver with transportation network company.

HB 3300

CARRIED OVER FROM 5/11: Requires primary care physician to serve specified percentage of medical assistance recipients in order to contract with Public Employees' Benefit Board or Oregon Educators Benefit Board to provide medical care.
