#### Public Hearing and Possible Work Session

SB 294 A

Grants Oregon Government Ethics Commission administrative rulemaking authority to assist in commission's enforcement of executive session provisions of public meeting laws.

SJR 4 A

Proposes amendment to Oregon Constitution to remove provisions fixing age for mandatory retirement of judges and provisions allowing Legislative Assembly or people to fix age for mandatory retirement of judges.

#### Work Session

HB 2058

Removes sunset on lobbyist exemption from reporting to Oregon Government Ethics Commission moneys spent on lobbying other registered lobbyists.

HB 2178

Requires campaign finance statement to be filed within two business days if aggregate amount of contributions equaling or exceeding \$2,500 from single donor is received during 14-day period immediately preceding election.

HB 2275

Changes name of Multimodal Transportation Fund to Connect Oregon Fund.

HB 3431

Extends deadline for owner of Metolius resort site to notify Department of Land Conservation and Development that owner has elected to seek approval of small-scale recreation community.

SB 292

Repeals duplicative provision regarding conflict of interest for planning commission members.

SB 293

Expands exemption from statutory gift limit to include admission provided to, or cost of food or beverage consumed by, relative of public official who accompanies public official at reception, meal or meeting.
