Public Hearing and Work Session

HB 2313 A

Prohibits person under 21 years of age from attempting to purchase, purchasing or acquiring marijuana items, and from entering portion of licensed premises where such persons are prohibited.

HB 2704 A

Creates exemption to prohibition on recording conversations for person openly recording law enforcement officer while officer is performing official duties in public place.

HB 3469

Increases penalty for crime of strangulation when committed knowing victim was pregnant.

The -1 amendments are being posted and considered for informational purposes only.

Work Session

HB 2310 A

CARRIED OVER FROM THE 6/1/2015 AGENDA: Allows Department of Corrections inmates to receive credit for time served for presentence incarceration after arrest for certain crimes related to sentencing crime.

HB 2571 A

Requires law enforcement agency to establish policies and procedures for use and retention of recordings from cameras worn upon police officer's person to record officer's interactions with members of public.

HB 2845 A

CARRIED OVER FROM THE 6/1/2015 AGENDA: Establishes conditions under which person may sell guaranteed asset protection waiver in connection with sale or lease of motor vehicle.

HB 3040 A

Directs Oregon Law Commission to study and make recommendations for changes to law relating to hearsay in criminal actions involving sex trafficking.

HB 3206 A

CARRIED OVER FROM THE 6/1/2015 AGENDA: Permits any person convicted of aggravated murder or felony with relevant DNA evidence to file motion for DNA testing.

HB 3365 A

CARRIED OVER FROM THE 6/1/2015 AGENDA: Modifies crime of displaying obscene materials to minors.

- HB 3399 A
CARRIED OVER FROM THE 6/1/2015 AGENDA: Requires justice court or municipal court to record criminal proceedings.
- HB 3452 A
CARRIED OVER FROM THE 6/1/2015 AGENDA: Provides that contract to allow use of property or facilities by nonprofit organization providing services to youths or by educational provider may not require individual participant to indemnify property owner for damages not caused by individual participant.
- HB 3468 **
Adds threatening to cause physical injury to animal to induce other person to engage in conduct as manner of committing crime of coercion. **Subsequent Referral(s) to Ways and Means

Possible Reconsideration and Work Session

- HB 2366 A
Modifies filing, motion and certificate fees in adoption proceedings.
For the purpose of consideration of amendments.
- HB 3524 A
Requires state, when selling or disposing of real property, to grant right of first refusal to developers of affordable housing.
For the purpose of consideration of amendments.
