SUMMARY

14	SECTION 1. Sections 2 to 79 of this 2015 Act are added to and made
15	a part of ORS chapter 110.

17	UNIFORM INTERSTATE FAMILY SUPPORT ACT
18	ARTICLE 1
19	(General Provisions)
20	

- SECTION 2. This chapter may be cited as the Uniform Interstate Family Support Act.
- 3 SECTION 3. As used in this chapter:

- (1) "Child" means an individual, whether over or under the age of majority, who is or is alleged to be owed a duty of support by the individual's parent or who is or is alleged to be the beneficiary of a support order directed to the parent.
 - (2) "Child support order" means a support order for a child, including a child who has attained the age of majority under the law of the issuing state or foreign country.
- 13 (3) "Convention" means the Convention on the International Re-12 covery of Child Support and Other Forms of Family Maintenance, 13 concluded at The Hague on November 23, 2007.
- 14 (4) "Duty of support" means an obligation imposed or imposable by 15 law to provide support for a child, spouse or former spouse, including 16 an unsatisfied obligation to provide support.
- 17 (5) "Foreign country" means a country, or a political subdivision 18 of a country, other than the United States, that authorizes the issu-19 ance of support orders and:
- 20 (a) That has been declared under the law of the United States to 21 be a foreign reciprocating country;
- 22 (b) That has established a reciprocal arrangement for child support 23 with this state as provided in section 25 of this 2015 Act;
- (c) That has enacted a law or established procedures for the issuance and enforcement of support orders that are substantially similar to the procedures under this chapter; or
- 27 (d) In which the Convention is in force with respect to the United 28 States.
- 29 (6) "Foreign support order" means a support order of a foreign 30 tribunal.
- 31 (7) "Foreign tribunal" means a court, administrative agency or

- 1 quasi-judicial entity of a foreign country that is authorized to estab-
- 2 lish, enforce or modify support orders or to determine parentage of a
- 3 child. "Foreign tribunal" includes a competent authority under the
- 4 Convention.
- 5 (8) "Home state" means the state or foreign country in which a
- 6 child lived with a parent or a person acting as parent for at least six
- 7 consecutive months immediately preceding the time of filing of a pe-
- 8 tition or comparable pleading for support and, if a child is less than
- 9 six months old, the state or foreign country in which the child lived
- 10 from birth with the parent or person acting as parent. A period of
- 11 temporary absence of the child, parent or person acting as parent is
- 12 counted as part of the six-month or other period.
- 13 (9) "Income" includes earnings or other periodic entitlements to
- 14 money from any source and any other property subject to withholding
- 15 for support under the law of this state.
- 16 (10) "Income withholding order" means an order or other legal
- 17 process directed to an obligor's employer or other debtor issued pur-
- suant to ORS 25.372 to 25.427 to withhold support from the income of
- 19 the obligor.
- 20 (11) "Initiating tribunal" means the tribunal of a state or foreign
- 21 country from which a petition or comparable pleading is forwarded or
- 22 in which a petition or comparable pleading is filed for forwarding to
- 23 another state or foreign country.
- 24 (12) "Issuing foreign country" means the foreign country in which
- 25 a tribunal issues a support order or a judgment determining parentage
- 26 of a child.
- 27 (13) "Issuing state" means the state in which a tribunal issues a
- 28 support order or a judgment determining parentage of a child.
- 29 (14) "Issuing tribunal" means the tribunal of a state or foreign
- 30 country that issues a support order or a judgment determining par-
- 31 entage of a child.

- 1 (15) "Law" includes decisional and statutory law and rules and 2 regulations having the force of law.
- 3 (16) "Obligee" means:

- (a) An individual to whom a duty of support is or is alleged to be owed or in whose favor a support order or a judgment determining parentage of a child has been issued;
 - (b) A foreign country, state or political subdivision of a state to which the rights under a duty of support or support order have been assigned or which has independent claims based on financial assistance provided to an individual obligee in place of child support;
- 11 (c) An individual seeking a judgment determining parentage of the 12 individual's child; or
- (d) A person that is a creditor in a proceeding under sections 62 to
 74 of this 2015 Act.
- 15 (17) "Obligor" means an individual, or the estate of a decedent, 16 that:
- 17 (a) Owes or is alleged to owe a duty of support;
- 18 (b) Is alleged but has not been adjudicated to be a parent of a child;
- 19 (c) Is liable under a support order; or
- 20 (d) Is a debtor in a proceeding under sections 62 to 74 of this 2015 21 Act.
- 22 (18) "Outside this state" means a location in another state or a 23 country other than the United States, whether or not the country is 24 a foreign country.
- (19) "Person" means an individual, corporation, business trust, estate, trust, partnership, limited liability company, association, joint venture, public corporation, government, governmental subdivision, agency, instrumentality or any other legal or commercial entity.
- 29 **(20)** "Record" means information that is inscribed on a tangible 30 medium or that is stored in an electronic or other medium and is re-31 trievable in perceivable form.

- 1 (21) "Register" means to file in a tribunal of this state a support 2 order or judgment determining parentage of a child issued in another 3 state or a foreign country.
- 4 (22) "Registering tribunal" means a tribunal in which a support or-5 der or judgment determining parentage of a child is registered.
- 6 (23) "Responding state" means a state in which a petition or com-7 parable pleading for support or to determine parentage of a child is 8 filed or to which a petition or comparable pleading is forwarded for 9 filing from another state or a foreign country.
- 10 (24) "Responding tribunal" means the authorized tribunal in a re-11 sponding state or foreign country.
- 12 **(25)** "Spousal support order" means a support order for a spouse or 13 former spouse of the obligor.
- 14 (26) "State" means a state of the United States, the District of 15 Columbia, Puerto Rico, the United States Virgin Islands, any territory 16 or insular possession under the jurisdiction of the United States or an 17 Indian nation or tribe.
- 18 (27) "Support enforcement agency" means a public official, govern-19 mental entity or private agency authorized to:
- 20 (a) Seek enforcement of support orders or laws relating to the duty 21 of support;
- 22 (b) Seek establishment or modification of child support;
- 23 (c) Request determination of parentage of a child;
- 24 (d) Attempt to locate obligors or their assets; or
- 25 (e) Request determination of the controlling child support order.
- (28) "Support order" means a judgment, decree, order, decision or directive, whether temporary, final or subject to modification, issued in a state or foreign country for the benefit of a child, a spouse or a former spouse, that provides for monetary support, health care, arrearages, retroactive support or reimbursement for financial assistance provided to an individual obligee in place of child support. The

- 1 term may include related costs and fees, interest, income withholding,
- 2 automatic adjustment, reasonable attorney fees and other relief.
- 3 (29) "Tribunal" means a court, administrative agency or quasi-
- 4 judicial entity authorized to establish, enforce or modify support or-
- 5 ders or to determine parentage of a child.
- 6 SECTION 4. The tribunals of this state are the circuit court, the
- 7 administrator as defined in ORS 25.010, the Department of Justice or
- 8 an administrative law judge of the Employment Department, as ap-
- 9 propriate.
- SECTION 5. (1) Remedies provided by this chapter are cumulative
- and do not affect the availability of remedies under other law or the
- 12 recognition of a foreign support order on the basis of comity.
- 13 (2) This chapter does not:
- 14 (a) Provide the exclusive method of establishing or enforcing a
- 15 support order under the law of this state; or
- 16 (b) Grant a tribunal of this state jurisdiction to render judgment
- 17 or issue an order relating to child custody or visitation in a proceeding
- 18 under this chapter.
- 19 SECTION 6. (1) A tribunal of this state shall apply sections 2 to 61
- of this 2015 Act and, as applicable, sections 62 to 74 of this 2015 Act to
- 21 a support proceeding involving:
- 22 (a) A foreign support order;
- 23 **(b) A foreign tribunal; or**
- 24 (c) An obligee, obligor or child residing in a foreign country.
- 25 (2) A tribunal of this state that is requested to recognize and en-
- 26 force a support order on the basis of comity may apply the procedural
- 27 and substantive provisions of sections 2 to 61 of this 2015 Act.
- 28 (3) Sections 62 to 74 of this 2015 Act apply only to a support pro-
- 29 ceeding under the Convention. In such a proceeding, if a provision of
- 30 sections 62 to 74 of this 2015 Act is inconsistent with sections 2 to 61
- of this 2015 Act, sections 62 to 74 of this 2015 Act control.

ARTICLE 2

2	(Jurisdiction)
3	
4	SECTION 7. (1) In a proceeding to establish or enforce a support
5	order or to determine parentage of a child, a tribunal of this state may
6	exercise personal jurisdiction over a nonresident individual or the
7	individual's guardian or conservator if:
8	(a) The individual is personally served with notice within this state;
9	(b) The individual submits to the jurisdiction of this state by con-
10	sent in a record, by entering a general appearance or by filing a re-
11	sponsive document having the effect of waiving any contest to
12	personal jurisdiction;
13	(c) The individual resided with the child in this state;
14	(d) The individual resided in this state and provided prenatal ex-
15	penses or support for the child;
16	(e) The child resides in this state as a result of the acts or directives
17	of the individual;
18	(f) The individual engaged in sexual intercourse in this state and
19	the child may have been conceived by that act of intercourse;
20	(g) The individual asserted parentage of a child in the registry
21	maintained in this state by the Center for Health Statistics of the
22	Oregon Health Authority by filing a voluntary acknowledgment of
23	paternity under ORS 109.070; or
24	(h) There is any other basis consistent with the Constitutions of the
25	State of Oregon and the United States for the exercise of personal ju-
26	risdiction.
27	(2) The bases of personal jurisdiction set forth in subsection (1) of
28	this section or in any other law of this state may not be used to ac-
29	quire personal jurisdiction for a tribunal of this state to modify a child
30	support order of another state unless the requirements of section 56
31	of this 2015 Act are met or, in the case of a foreign support order,

- 1 unless the requirements of section 60 of this 2015 Act are met.
- 2 SECTION 8. Personal jurisdiction acquired by a tribunal of this
- 3 state in a proceeding under this chapter or other law of this state re-
- 4 lating to a support order continues as long as a tribunal of this state
- 5 has continuing, exclusive jurisdiction to modify its order or continuing
- 6 jurisdiction to enforce its order as provided by sections 11, 12 and 17
- 7 of this 2015 Act.
- 8 SECTION 9. Under this chapter, a tribunal of this state may serve
- 9 as an initiating tribunal to forward proceedings to a tribunal of an-
- 10 other state, and as a responding tribunal for proceedings initiated in
- 11 another state or a foreign country.
- 12 SECTION 10. (1) A tribunal of this state may exercise jurisdiction
- 13 to establish a support order if the petition or comparable pleading is
- 14 filed after a pleading is filed in another state or a foreign country only
- 15 **if:**
- 16 (a) The petition or comparable pleading in this state is filed before
- 17 the expiration of the time allowed in the other state or the foreign
- 18 country for filing a responsive pleading challenging the exercise of
- 19 jurisdiction by the other state or the foreign country;
- 20 (b) The contesting party timely challenges the exercise of jurisdic-
- 21 tion in the other state or the foreign country; and
- (c) If relevant, this state is the home state of the child.
- 23 (2) A tribunal of this state may not exercise jurisdiction to establish
- 24 a support order if the petition or comparable pleading is filed before
- 25 a petition or comparable pleading is filed in another state or a foreign
- 26 country if:
- 27 (a) The petition or comparable pleading in the other state or foreign
- 28 country is filed before the expiration of the time allowed in this state
- 29 for filing a responsive pleading challenging the exercise of jurisdiction
- 30 by this state;

(b) The contesting party timely challenges the exercise of jurisdic-

1 tion in this state; and

- 2 (c) If relevant, the other state or foreign country is the home state 3 of the child.
- SECTION 11. (1) A tribunal of this state that has issued a child support order consistent with the law of this state has and shall exercise continuing, exclusive jurisdiction to modify its child support order if the order is the controlling order and:
 - (a) At the time of the filing of a request for modification, this state is the residence of the obligor, the individual obligee or the child for whose benefit the support order is issued; or
 - (b) Even if this state is not the residence of the obligor, the individual obligee or the child for whose benefit the support order is issued, the parties consent in a record or in open court that the tribunal of this state may continue to exercise jurisdiction to modify its order.
 - (2) A tribunal of this state that has issued a child support order consistent with the law of this state may not exercise continuing, exclusive jurisdiction to modify the order if:
 - (a) All of the parties who are individuals file consent in a record with the tribunal of this state that a tribunal of another state that has jurisdiction over at least one of the parties who is an individual or that is located in the state of residence of the child may modify the order and assume continuing, exclusive jurisdiction; or
 - (b) The tribunal's order is not the controlling order.
 - (3) If a tribunal of another state has issued a child support order pursuant to the Uniform Interstate Family Support Act or a law substantially similar to that Act which modifies a child support order of a tribunal of this state, tribunals of this state shall recognize the continuing, exclusive jurisdiction of the tribunal of the other state.
 - (4) A tribunal of this state that lacks continuing, exclusive jurisdiction to modify a child support order may serve as an initiating tribunal to request a tribunal of another state to modify a support

1 order issued in that state.

- 2 (5) A temporary support order issued ex parte or pending resolution 3 of a jurisdictional conflict does not create continuing, exclusive juris-4 diction in the issuing tribunal.
 - SECTION 12. (1) A tribunal of this state that has issued a child support order consistent with the law of this state may serve as an initiating tribunal to request a tribunal of another state to enforce:
 - (a) The order if the order is the controlling order and has not been modified by a tribunal of another state that assumed jurisdiction pursuant to the Uniform Interstate Family Support Act; or
 - (b) A money judgment for arrears of support and interest on the order accrued before a determination that an order of a tribunal of another state is the controlling order.
 - (2) A tribunal of this state having continuing jurisdiction over a support order may act as a responding tribunal to enforce the order.
 - SECTION 13. (1) If a proceeding is brought under this chapter and only one tribunal has issued a child support order, the order of that tribunal controls and must be recognized.
- (2) If a proceeding is brought under this chapter and two or more child support orders have been issued by tribunals of this state, another state or a foreign country with regard to the same obligor and same child, a tribunal of this state having personal jurisdiction over both the obligor and individual obligee shall apply the following rules and by order shall determine which order controls and must be recognized:
- 26 (a) If only one of the tribunals would have continuing, exclusive 27 jurisdiction under this chapter the order of that tribunal controls.
- 28 (b) If more than one of the tribunals would have continuing, ex-29 clusive jurisdiction under this chapter:
- 30 (A) An order issued by a tribunal in the current home state of the 31 child controls; or

- 1 (B) If an order has not been issued in the current home state of the child, the order most recently issued controls. 2
- (c) If none of the tribunals would have continuing, exclusive juris-3 diction under this chapter, the tribunal of this state shall issue a child support order, which controls.

- (3) If two or more child support orders have been issued for the 6 same obligor and same child, upon request of a party who is an individual or that is a support enforcement agency, a tribunal of this state having personal jurisdiction over both the obligor and the obligee who is an individual shall determine which order controls under subsection (2) of this section. The request may be filed with a registration for 12 enforcement or registration for modification pursuant to sections 46 to 61 of this 2015 Act or may be filed as a separate proceeding.
 - (4) A request to determine which is the controlling order must be accompanied by a copy of every child support order in effect and the applicable record of payments. The requesting party shall give notice of the request to each party whose rights may be affected by the determination.
- (5) The tribunal that issued the controlling order under subsection 19 (1), (2) or (3) of this section has continuing jurisdiction to the extent 20 provided in section 11 or 12 of this 2015 Act. 21
- (6) A tribunal of this state that determines by order which is the 22 controlling order under subsection (2)(a) or (b) or (3) of this section 23 or that issues a new controlling order under subsection (2)(c) of this 24 section shall state in that order: 25
- (a) The basis upon which the tribunal made its determination; 26
- (b) The amount of prospective support, if any; and 27
- (c) The total amount of consolidated arrears and accrued interest, 28 if any, under all of the orders after all payments made are credited 29 as provided by section 15 of this 2015 Act. 30
 - (7) Within 30 days after issuance of an order determining which is

- the controlling order, the party obtaining the order shall file a certified copy of it in each tribunal that issued or registered an earlier order of child support. A party or support enforcement agency obtaining the order that fails to file a certified copy is subject to appropriate sanctions by a tribunal in which the issue of failure to file arises. The failure to file does not affect the validity or enforceability of the controlling order.
 - (8) An order that has been determined to be the controlling order, or a judgment for consolidated arrears of support and interest, if any, made pursuant to this section must be recognized in proceedings under this chapter.

- SECTION 14. In responding to registrations or petitions for enforcement of two or more child support orders in effect at the same time with regard to the same obligor and different individual obligees, at least one of which was issued by a tribunal of another state or a foreign country, a tribunal of this state shall enforce those orders in the same manner as if the orders had been issued by a tribunal of this state.
- SECTION 15. A tribunal of this state shall credit amounts collected for a particular period pursuant to any child support order against the amounts owed for the same period under any other child support order for support of the same child issued by a tribunal of this state, another state or a foreign country.
- SECTION 16. A tribunal of this state exercising personal jurisdic-24 tion over a nonresident in a proceeding under this chapter, under 25 other law of this state relating to a support order or recognizing a 26 foreign support order may receive evidence from outside this state 27 pursuant to section 33 of this 2015 Act, communicate with a tribunal 28 outside this state pursuant to section 34 of this 2015 Act and obtain 29 discovery through a tribunal outside this state pursuant to section 35 30 of this 2015 Act. In all other respects, sections 18 to 61 of this 2015 Act 31

- do not apply and the tribunal shall apply the procedural and substantive law of this state.
 - SECTION 17. (1) A tribunal of this state issuing a spousal support order consistent with the law of this state has continuing, exclusive jurisdiction to modify the spousal support order throughout the existence of the support obligation.
 - (2) A tribunal of this state may not modify a spousal support order issued by a tribunal of another state or a foreign country having continuing, exclusive jurisdiction over that order under the law of that state or foreign country.
 - (3) A tribunal of this state that has continuing, exclusive jurisdiction over a spousal support order may serve as:
 - (a) An initiating tribunal to request a tribunal of another state to enforce the spousal support order issued in this state; or
 - (b) A responding tribunal to enforce or modify its own spousal support order.

18 ARTICLE 3

(Civil Provisions of General Application)

- SECTION 18. (1) Except as otherwise provided in this chapter, sections 18 to 36 of this 2015 Act apply to all proceedings under this chapter.
- (2) An individual petitioner or a support enforcement agency may initiate a proceeding authorized under this chapter by filing a petition in an initiating tribunal for forwarding to a responding tribunal or by filing a petition or a comparable pleading directly in a tribunal of another state or a foreign country that has or can obtain personal jurisdiction over the respondent.
- SECTION 19. A minor parent, or a guardian or other legal representative of a minor parent, may maintain a proceeding on behalf of

1 or for the benefit of the minor's child.

- 2 <u>SECTION 20.</u> Except as otherwise provided in this chapter, a re-3 sponding tribunal of this state shall:
 - (1) Apply the procedural and substantive law generally applicable to similar proceedings originating in this state and may exercise all powers and provide all remedies available in those proceedings; and
 - (2) Determine the duty of support and the amount payable in accordance with the law and support guidelines of this state.
- 9 <u>SECTION 21.</u> (1) Upon the filing of a petition authorized by this 10 chapter, an initiating tribunal of this state shall forward the petition 11 and its accompanying documents:
 - (a) To the responding tribunal or appropriate support enforcement agency in the responding state; or
 - (b) If the identity of the responding tribunal is unknown, to the state information agency of the responding state with a request that the petition and accompanying documents be forwarded to the appropriate tribunal and that receipt be acknowledged.
 - (2) If requested by the responding tribunal, a tribunal of this state shall issue a certificate or other document and make findings required by the law of the responding state. If the responding tribunal is in a foreign country, upon request the tribunal of this state shall specify the amount of support sought, convert that amount into the equivalent amount in the foreign currency under applicable official or market exchange rate as publicly reported and provide any other documents necessary to satisfy the requirements of the responding foreign tribunal.
- SECTION 22. (1) When a responding tribunal of this state receives a petition or comparable pleading from an initiating tribunal or directly pursuant to section 18 (2) of this 2015 Act, the responding tribunal shall cause the petition or pleading to be filed and notify the petitioner where and when it was filed.

- 1 (2) A responding tribunal of this state, to the extent not prohibited 2 by other law, may do one or more of the following:
- (a) Establish or enforce a support order, modify a child support order, determine the controlling child support order or determine parentage of a child;
- 6 (b) Order an obligor to comply with a support order, specifying the 7 amount and the manner of compliance;
- 8 (c) Order income withholding;
- 9 (d) Determine the amount of any arrearages and specify a method 10 of payment;
- 11 (e) Enforce orders by civil or criminal contempt, or both;
- 12 (f) Set aside property for satisfaction of the support order;
- 13 (g) Place liens and order execution on the obligor's property;
- (h) Order an obligor to keep the tribunal informed of the obligor's current residential address, electronic mail address, telephone number, employer, address of employment and telephone number at the place of employment;
- (i) Issue a warrant for an obligor who has failed, after proper notice, to appear at a hearing ordered by the tribunal and enter the warrant in any local and state computer systems for criminal warrants;
- 22 (j) Order the obligor to seek appropriate employment by specified 23 methods;
- 24 (k) Award reasonable attorney fees and other fees and costs; and
- 25 (L) Grant any other available remedy.
- 26 (3) A responding tribunal of this state shall include in a support 27 order issued under this chapter, or in the documents accompanying 28 the order, the calculations on which the support order is based.
- 29 (4) A responding tribunal of this state may not condition the pay-30 ment of a support order issued under this chapter upon compliance 31 by a party with provisions for visitation.

2

- (5) If a responding tribunal of this state issues an order under this chapter, the tribunal shall send a copy of the order to the petitioner and the respondent and to the initiating tribunal, if any.
- (6) If requested to enforce a support order, arrears or judgment or to modify a support order stated in a foreign currency, a responding tribunal of this state shall convert the amount stated in the foreign currency to the equivalent amount in dollars under the applicable official or market exchange rate as publicly reported.
- 9 <u>SECTION 23.</u> If a petition or comparable pleading is received by an inappropriate tribunal of this state, the tribunal shall forward the pleading and accompanying documents to an appropriate tribunal of this state or another state and notify the petitioner where and when the pleading was sent.
- SECTION 24. (1) A support enforcement agency of this state, upon request, shall provide services to a petitioner in a proceeding under this chapter.
- 17 (2) A support enforcement agency of this state that is providing 18 services to the petitioner shall:
- 19 (a) Take all steps necessary to enable an appropriate tribunal of this 20 state, another state or a foreign country to obtain jurisdiction over the 21 respondent;
- 22 (b) Request an appropriate tribunal to set a date, time and place for 23 a hearing;
- 24 (c) Make a reasonable effort to obtain all relevant information, in-25 cluding information as to income and property of the parties;
- (d) Within two days, exclusive of Saturdays, Sundays and legal holidays, after receipt of notice in a record from an initiating, responding or registering tribunal, send a copy of the notice to the petitioner;
- 30 (e) Within two days, exclusive of Saturdays, Sundays and legal 31 holidays, after receipt of communication in a record from the re-

- spondent or the respondent's attorney, send a copy of the communication to the petitioner; and
- 3 (f) Notify the petitioner if jurisdiction over the respondent cannot 4 be obtained.
- (3) A support enforcement agency of this state that requests registration of a child support order in this state for enforcement or for modification shall make reasonable efforts:
- 8 (a) To ensure that the order to be registered is the controlling or-9 der; or

- (b) If two or more child support orders exist and the identity of the controlling order has not been determined, to ensure that a request for such a determination is made in a tribunal having jurisdiction to do so.
- (4) A support enforcement agency of this state that requests registration and enforcement of a support order, arrears or judgment stated in a foreign currency shall convert the amounts stated in the foreign currency into the equivalent amounts in dollars under the applicable official or market exchange rate as publicly reported.
- (5) A support enforcement agency of this state shall issue or request a tribunal of this state to issue a child support order and an income withholding order that redirect payment of current support, arrears and interest if requested to do so by a support enforcement agency of another state pursuant to section 36 of this 2015 Act.
- (6) This chapter does not create or negate a relationship of attorney and client or other fiduciary relationship between a support enforcement agency or the attorney for the agency and the individual being assisted by the agency.
- SECTION 25. (1) If the appropriate state official or agency determines that the support enforcement agency is neglecting or refusing to provide services to an individual, the state official or agency may order the agency to perform its duties under this chapter or may

- 1 provide those services directly to the individual.
- 2 (2) The appropriate state official or agency may determine that a 3 foreign country has established a reciprocal arrangement for child 4 support with this state and take appropriate action for notification of 5 the determination.
- 6 <u>SECTION 26.</u> An individual may employ private counsel to repre-7 sent the individual in proceedings authorized by this chapter.
- 8 <u>SECTION 27.</u> (1) The Attorney General's office is the state infor-9 mation agency under this chapter.
 - (2) The state information agency shall:

- (a) Compile and maintain a current list, including addresses, of the tribunals in this state that have jurisdiction under this chapter and any support enforcement agencies in this state and transmit a copy to the state information agency of every other state;
- (b) Maintain a register of names and addresses of tribunals and support enforcement agencies received from other states;
- (c) Forward to the appropriate tribunal in the county in this state in which the obligee who is an individual or the obligor resides, or in which the obligor's property is believed to be located, all documents concerning a proceeding under this chapter received from another state or a foreign country; and
- (d) Obtain information concerning the location of the obligor and the obligor's property within this state not exempt from execution, by such means as postal verification and federal or state locator services, examination of telephone directories, requests for the obligor's address from employers and examination of governmental records including, to the extent not prohibited by other law, those relating to real property, vital statistics, law enforcement, taxation, motor vehicles, driver licenses and Social Security.
- SECTION 28. (1) In a proceeding under this chapter, a petitioner seeking to establish a support order, to determine parentage of a child

or to register and modify a support order of a tribunal of another state or a foreign country must file a petition. Unless otherwise ordered under section 29 of this 2015 Act, the petition or accompanying docu-ments must provide, so far as known, the name, residential address and Social Security numbers of the obligor and the obligee or the parent and alleged parent and the name, sex, residential address, So-cial Security number and date of birth of each child for whose benefit support is sought or whose parentage is to be determined. Unless filed at the time of registration, the petition must be accompanied by a copy of any support order known to have been issued by another tribunal. The petition may include any other information that may assist in locating or identifying the respondent.

(2) The petition must specify the relief sought. The petition and accompanying documents must conform substantially with the requirements imposed by the forms mandated by federal law for use in cases filed by a support enforcement agency.

SECTION 29. If a party alleges in an affidavit or a pleading under oath that the health, safety or liberty of a party or child would be jeopardized by disclosure of specific identifying information, that information must be sealed and may not be disclosed to the other party or the public. After a hearing in which a tribunal takes into consideration the health, safety or liberty of the party or child, the tribunal may order disclosure of information that the tribunal determines to be in the interest of justice.

SECTION 30. (1) The petitioner may not be required to pay a filing fee or other costs.

(2) If an obligee prevails, a responding tribunal of this state may assess against an obligor filing fees, reasonable attorney fees, other costs and necessary travel and other reasonable expenses incurred by the obligee and the obligee's witnesses. The tribunal may not assess fees, costs or expenses against the obligee or the support enforcement

- agency of either the initiating or responding state or foreign country except as provided by other law. Attorney fees may be taxed as costs and may be ordered paid directly to the attorney, who may enforce the order in the attorney's own name. Payment of support owed to the obligee has priority over fees, costs and expenses.
 - (3) The tribunal shall order the payment of costs and reasonable attorney fees if it determines that a hearing was requested primarily for delay. In a proceeding under sections 46 to 61 of this 2015 Act, a hearing is presumed to have been requested primarily for delay if a registered support order is confirmed or enforced without change.
 - SECTION 31. (1) Participation by a petitioner in a proceeding under this chapter before a responding tribunal, whether in person, by private attorney or through services provided by the support enforcement agency, does not confer personal jurisdiction over the petitioner in another proceeding.
- 16 (2) A petitioner is not amenable to service of civil process while 17 physically present in this state to participate in a proceeding under 18 this chapter.
- 19 (3) The immunity granted by this section does not extend to civil 20 litigation based on acts unrelated to a proceeding under this chapter 21 committed by a party while physically present in this state to partic-22 ipate in the proceeding.
 - SECTION 32. A party whose parentage of a child has been previously determined by or pursuant to law may not plead nonparentage as a defense to a proceeding under this chapter.
- SECTION 33. (1) The physical presence of a nonresident party who is an individual in a tribunal of this state is not required for the establishment, enforcement or modification of a support order or the rendition of a judgment determining parentage of a child.
- 30 (2) An affidavit, a document substantially complying with federally mandated forms or a document incorporated by reference in an affi-

- davit or form that would not be excluded under the hearsay rule if given in person is admissible in evidence if given under penalty of perjury by a party or witness residing outside this state.
 - (3) A copy of the record of child support payments certified as a true copy of the original by the custodian of the record may be forwarded to a responding tribunal. The copy is evidence of the facts asserted in the record and is admissible to show whether payments were made.
 - (4) Copies of bills for testing for parentage of a child and for prenatal and postnatal health care of the mother and child that are furnished to the adverse party at least 10 days before trial are admissible in evidence to prove the amount of the charges billed and that the charges were reasonable, necessary and customary.
 - (5) Documentary evidence transmitted from outside this state to a tribunal of this state by telephone, telecopier or other electronic means that do not provide an original record may not be excluded from evidence on an objection based on the means of transmission.
 - (6) In a proceeding under this chapter, a tribunal of this state shall permit a party or witness residing outside this state to be deposed or to testify under penalty of perjury by telephone, audiovisual means or other electronic means at a designated tribunal or other location. A tribunal of this state shall cooperate with other tribunals in designating an appropriate location for the deposition or testimony.
- 24 (7) If a party called to testify at a civil hearing refuses to answer 25 on the ground that the testimony may be self-incriminating, the trier 26 of fact may draw an adverse inference from the refusal.
 - (8) A privilege against disclosure of communications between spouses does not apply in a proceeding under this chapter.
- (9) The defense of immunity based on the relationship of husband and wife or parent and child does not apply in a proceeding under this chapter.

- 1 (10) A voluntary acknowledgment of paternity, certified as a true 2 copy, is admissible to establish parentage of the child.
- SECTION 34. A tribunal of this state may communicate with a tribunal outside this state in a record or by telephone, electronic mail or other means to obtain information concerning the laws of that tribunal, the legal effect of a judgment, decree or order of that tribunal and the status of a proceeding. A tribunal of this state may furnish similar information by similar means to a tribunal outside this state.

10 **SECTION 35. A tribunal of this state may:**

SECTION 38. A tribunal of this state authorized to determine parentage of a child may serve as a responding tribunal in a proceeding to determine parentage of a child brought under this chapter or a law or procedure substantially similar to this chapter.

ARTICLE 5

(Enforcement of Support Order Without Registration)

SECTION 39. An income withholding order issued in another state may be sent by or on behalf of the obligee, or by the support enforcement agency, to the person defined as the obligor's employer under the income withholding law of this state without first filing a petition or comparable pleading or registering the order with a tribunal of this state.

- SECTION 40. (1) Upon receipt of an income withholding order, the obligor's employer shall immediately provide a copy of the order to the obligor.
 - (2) The employer shall treat an income withholding order issued in another state that appears regular on its face as if it had been issued by a tribunal of this state.
 - (3) Except as otherwise provided in subsection (4) of this section and section 41 of this 2015 Act, the employer shall withhold and distribute the funds as directed in the income withholding order by complying with terms of the order that specify:
 - (a) The duration and amount of periodic payments of current child support, stated as a sum certain;
 - (b) The person designated to receive payments and the address to which the payments are to be forwarded;
- 30 (c) Medical support, whether in the form of a periodic cash pay-31 ment, stated as a sum certain or by ordering the obligor to provide

- 1 health insurance coverage for the child under a policy available 2 through the obligor's employment;
- (d) The amount of periodic payments of fees and costs for a support
 enforcement agency, the issuing tribunal and the obligee's attorney,
 stated as sums certain; and
 - (e) The amount of periodic payments of arrearages and interest on arrearages, stated as sums certain.

- 8 (4) An employer shall comply with the law of the state of the 9 obligor's principal place of employment for withholding from income 10 with respect to:
 - (a) The employer's fee for processing an income withholding order;
- 12 **(b)** The maximum amount permitted to be withheld from the 13 **obligor's income**; and
 - (c) The times within which the employer must implement the income withholding order and forward the child support payment.
 - SECTION 41. If an obligor's employer receives two or more income withholding orders with respect to the earnings of the same obligor, the employer satisfies the terms of the orders if the employer complies with the law of the state of the obligor's principal place of employment to establish the priorities for withholding and allocating income withheld for two or more child support obligees.
- SECTION 42. An employer that complies with an income withholding order issued in another state in accordance with sections 39 to 45 of this 2015 Act is not subject to civil liability to an individual or agency with regard to the employer's withholding of child support from the obligor's income.
- SECTION 43. An employer that willfully fails to comply with an income withholding order issued in another state and received for enforcement is subject to the same penalties that may be imposed for noncompliance with an order issued by a tribunal of this state.
 - SECTION 44. (1) An obligor may contest the validity or enforcement

- of an income withholding order issued in another state and received directly by an employer in this state by registering the order in a tribunal of this state and filing a contest to that order as provided in sections 46 to 61 of this 2015 Act or otherwise contesting the order in the same manner as if the order had been issued by a tribunal of this state.
 - (2) The obligor shall give notice of the contest to:
 - (a) A support enforcement agency providing services to the obligee;
 - (b) Each employer that has directly received an income withholding order relating to the obligor; and
 - (c) The person designated to receive payments in the income withholding order or, if no person is designated, to the obligee.
 - SECTION 45. (1) A party or support enforcement agency seeking to enforce a support order or an income withholding order, or both, issued in another state, or a foreign support order, may send the documents required for registering the order to a support enforcement agency of this state.
 - (2) Upon receipt of the documents, the support enforcement agency, without initially seeking to register the order, shall consider and, if appropriate, use any administrative procedure authorized by the law of this state to enforce a support order or an income withholding order, or both. If the obligor does not contest administrative enforcement, the order need not be registered. If the obligor contests the validity or administrative enforcement of the order, the support enforcement agency shall register the order pursuant to this chapter.

(Registration, Enforcement and Modification of Support Orders)

(Part 1. Registration for Enforcement of Support Order)

- SECTION 46. A support order or income withholding order issued in another state or a foreign support order may be registered in this state for enforcement.
- SECTION 47. (1) Except as otherwise provided in section 67 of this 2015 Act, a support order or income withholding order of another state or a foreign support order may be registered in this state by sending the following records to the appropriate tribunal in this state:
- 8 (a) A letter of transmittal to the tribunal requesting registration 9 and enforcement;
- 10 **(b)** Two copies, including one certified copy, of the order to be reg-11 istered, including any modification of the order;
- 12 (c) A sworn statement by the person requesting registration or a 13 certified statement by the custodian of the records showing the 14 amount of any arrearage;
- 15 (d) The name of the obligor and, if known:
- 16 (A) The obligor's address and Social Security number;
- 17 **(B)** The name and address of the obligor's employer and any other 18 source of income of the obligor; and
- 19 (C) A description and the location of property of the obligor in this 20 state not exempt from execution; and
- (e) Except as otherwise provided in section 29 of this 2015 Act, the name and address of the obligee and, if applicable, the person to whom support payments are to be remitted.
- 24 (2) Upon receipt of a request for registration, the registering 25 tribunal shall cause the order to be filed as an order of a tribunal of 26 another state or a foreign support order, together with one copy of the 27 documents and information, regardless of their form.
- 28 (3) A petition or comparable pleading seeking a remedy that must 29 be affirmatively sought under other law of this state may be filed at 30 the same time as the request for registration or later. The pleading 31 must specify the grounds for the remedy sought.

- 1 (4) If two or more orders are in effect, the person requesting regis-2 tration shall:
- (a) Furnish to the tribunal a copy of every support order asserted to be in effect in addition to the documents specified in this section;
 - (b) Specify the order alleged to be the controlling order, if any; and
- 6 (c) Specify the amount of consolidated arrears, if any.

- (5) A request for a determination of which is the controlling order may be filed separately or with a request for registration and enforcement or for registration and modification. The person requesting registration shall give notice of the request to each party whose rights may be affected by the determination.
- SECTION 48. (1) A support order or income withholding order issued in another state, or a foreign support order, is registered when the order is filed in the registering tribunal of this state.
- 15 (2) A registered support order issued in another state or a foreign 16 country is enforceable in the same manner and is subject to the same 17 procedures as an order issued by a tribunal of this state.
- (3) Except as otherwise provided in this chapter, a tribunal of this state shall recognize and enforce, but may not modify, a registered support order if the issuing tribunal had jurisdiction.
- 21 <u>SECTION 49.</u> (1) Except as otherwise provided in subsection (4) of 22 this section, the law of the issuing state or foreign country governs:
- 23 (a) The nature, extent, amount and duration of current payments 24 under a registered support order;
- 25 (b) The computation and payment of arrearages and accrual of in-26 terest on the arrearages under the support order; and
- 27 (c) The existence and satisfaction of other obligations under the 28 support order.
- 29 (2) In a proceeding for arrears under a registered support order, the 30 statute of limitation of this state, or of the issuing state or foreign 31 country, whichever is longer, applies.

- (3) A responding tribunal of this state shall apply the procedures and remedies of this state to enforce current support and collect arrears and interest due on a support order of another state or a foreign country registered in this state.
- (4) After a tribunal of this state or another state determines which is the controlling order and issues an order consolidating arrears, if any, a tribunal of this state shall prospectively apply the law of the state or foreign country issuing the controlling order, including its law on interest on arrears, on current and future support and on consolidated arrears.

(Part 2. Contest of Validity or Enforcement)

- SECTION 50. (1) When a support order or income withholding order issued in another state or a foreign support order is registered, the registering tribunal of this state shall notify the nonregistering party. The notice must be accompanied by a copy of the registered order and the documents and relevant information accompanying the order.
 - (2) A notice must inform the nonregistering party:
- (a) That a registered support order is enforceable as of the date of registration in the same manner as an order issued by a tribunal of this state;
 - (b) That a hearing to contest the validity or enforcement of the registered order must be requested within 20 days after notice unless the registered order is under section 68 of this 2015 Act;
 - (c) That failure to contest the validity or enforcement of the registered order in a timely manner will result in confirmation of the order and enforcement of the order and the alleged arrearages; and
 - (d) Of the amount of any alleged arrearages.
- 30 (3) If the registering party asserts that two or more orders are in effect, a notice must also:

- 1 (a) Identify the two or more orders and the order alleged by the registering party to be the controlling order and the consolidated ar-2 rears, if any; 3
 - (b) Notify the nonregistering party of the right to a determination of which is the controlling order;
 - (c) State that the procedures provided in subsection (2) of this section apply to the determination of which is the controlling order; and
 - (d) State that failure to contest the validity or enforcement of the order alleged to be the controlling order in a timely manner may result in confirmation that the order is the controlling order.
 - (4) Upon registration of an income withholding order for enforcement, the support enforcement agency or the registering tribunal shall notify the obligor's employer pursuant to the income withholding law of this state.
- SECTION 51. (1) A nonregistering party seeking to contest the va-15 lidity or enforcement of a registered support order in this state shall 16 request a hearing within the time required by section 50 of this 2015 17 Act. The nonregistering party may seek to vacate the registration, to 18 assert any defense to an allegation of noncompliance with the regis-19 tered order or to contest the remedies being sought or the amount of 20 21 any alleged arrearages pursuant to section 52 of this 2015 Act.
- (2) If the nonregistering party fails to contest the validity or 22 enforcement of the registered support order in a timely manner, the order is confirmed by operation of law.
- (3) If a nonregistering party requests a hearing to contest the va-25 lidity or enforcement of the registered support order, the registering 26 tribunal shall schedule the matter for hearing and give notice to the 27 parties of the date, time and place of the hearing. 28
- SECTION 52. (1) A party contesting the validity or enforcement of 29 a registered support order or seeking to vacate the registration has the 30 burden of proving one or more of the following defenses: 31

- (3) If the contesting party does not establish a defense under subsection (1) of this section to the validity or enforcement of a registered support order, the registering tribunal shall issue an order confirming the order.
- SECTION 53. Confirmation of a registered support order, whether by operation of law or after notice and hearing, precludes further contest of the order with respect to any matter that could have been asserted at the time of registration.

(Part 3. Registration and Modification of Child Support Order of Another State)

30 31

SECTION 54. A party or support enforcement agency seeking to

- modify, or to modify and enforce, a child support order issued in another state shall register that order in this state in the same manner provided in sections 46 to 53 of this 2015 Act if the order has not been registered. A petition for modification may be filed at the same time as a request for registration or later. The pleading must specify the grounds for modification.
- SECTION 55. A tribunal of this state may enforce a child support order of another state registered for purposes of modification in the same manner as if the order had been issued by a tribunal of this state, but the registered support order may be modified only if the requirements of section 56 or 58 of this 2015 Act have been met.
 - SECTION 56. (1) If section 58 of this 2015 Act does not apply, upon petition a tribunal of this state may modify a child support order issued in another state that is registered in this state if, after notice and hearing, the tribunal finds that:
 - (a) The following requirements are met:

 - (b) This state is the residence of the child, or a party who is an individual is subject to the personal jurisdiction of the tribunal of this state, and all of the parties who are individuals have filed consents in a record in the issuing tribunal for a tribunal of this state to modify the support order and assume continuing, exclusive jurisdiction.
- 28 (2) Modification of a registered child support order is subject to the 29 same requirements, procedures and defenses that apply to the modifi-30 cation of an order issued by a tribunal of this state, and the order may 31 be enforced and satisfied in the same manner.

- 1 (3) A tribunal of this state may not modify any aspect of a child support order that may not be modified under the law of the issuing state, including the duration of the obligation of support. If two or 3 more tribunals have issued child support orders for the same obligor and same child, the order that controls and must be so recognized under section 13 of this 2015 Act establishes the aspects of the support order which are nonmodifiable.
 - (4) In a proceeding to modify a child support order, the law of the state that is determined to have issued the initial controlling order governs the duration of the obligation of support. The obligor's fulfillment of the duty of support established by that order precludes imposition of a further obligation of support by a tribunal of this state.
 - (5) On the issuance of an order by a tribunal of this state modifying a child support order issued in another state, the tribunal of this state becomes the tribunal having continuing, exclusive jurisdiction.
- (6) Notwithstanding subsections (1) to (5) of this section and section 16 7 (2) of this 2015 Act, a tribunal of this state retains jurisdiction to 17 modify an order issued by a tribunal of this state if: 18
- (a) One party resides in another state; and 19

- 21 SECTION 57. If a child support order issued by a tribunal of this state is modified by a tribunal of another state that assumed jurisdic-22 tion pursuant to the Uniform Interstate Family Support Act, a 23 tribunal of this state: 24
- (1) May enforce its order that was modified only as to arrears and 25 interest accruing before the modification; 26
- (2) May provide appropriate relief for violations of its order that 27 occurred before the effective date of the modification; and 28
- (3) Shall recognize the modifying order of the other state upon 29 registration for the purpose of enforcement. 30
- SECTION 58. (1) If all of the parties who are individuals reside in 31

this state and the child does not reside in the issuing state, a tribunal of this state has jurisdiction to enforce and to modify the issuing state's child support order in a proceeding to register that order.

(2) A tribunal of this state exercising jurisdiction under this section shall apply the provisions of sections 2 to 6 of this 2015 Act, sections 7 to 17 of this 2015 Act, sections 46 to 61 of this 2015 Act and the procedural and substantive law of this state to the proceeding for enforcement or modification. Sections 18 to 36 of this 2015 Act, sections 37 and 38 of this 2015 Act, sections 39 to 45 of this 2015 Act, sections 62 to 74 of this 2015 Act and sections 75 and 76 of this 2015 Act do not apply.

SECTION 59. Within 30 days after issuance of a modified child support order, the party obtaining the modification shall file a certified copy of the order with the issuing tribunal that had continuing, exclusive jurisdiction over the earlier order, and in each tribunal in which the party knows the earlier order has been registered. A party who obtains the order and fails to file a certified copy is subject to appropriate sanctions by a tribunal in which the issue of failure to file arises. The failure to file does not affect the validity or enforceability of the modified order of the new tribunal having continuing, exclusive jurisdiction.

(Part 4. Registration and Modification of Foreign Child Support Order)

SECTION 60. (1) Except as otherwise provided in section 72 of this 2015 Act, if a foreign country lacks or refuses to exercise jurisdiction to modify its child support order pursuant to its laws, a tribunal of this state may assume jurisdiction to modify the child support order and bind all individuals subject to the personal jurisdiction of the tribunal whether the consent to modification of a child support order

- otherwise required of the individual pursuant to section 56 of this 2015 Act has been given or whether the individual seeking modification is 2 a resident of this state or of the foreign country. 3
 - (2) An order issued by a tribunal of this state modifying a foreign child support order pursuant to this section is the controlling order.

SECTION 61. A party or support enforcement agency seeking to modify, or to modify and enforce, a foreign child support order not under the Convention may register that order in this state under sections 46 to 53 of this 2015 Act if the order has not been registered. A petition for modification may be filed at the same time as a request for registration or at another time. The petition must specify the grounds for modification.

SECTION 62. As used in sections 62 to 74 of this 2015 Act:

- (1) "Application" means a request under the Convention by an 18 obligee or obligor, or on behalf of a child, made through a central authority for assistance from another central authority.
 - (2) "Central authority" means the entity designated by the United States or a foreign country described in section 3 (5)(d) of this 2015 Act to perform the functions specified in the Convention.
 - (3) "Convention support order" means a support order of a tribunal of a foreign country described in section 3 (5)(d) of this 2015 Act.
 - (4) "Direct request" means a petition filed by an individual in a tribunal of this state in a proceeding involving an obligee, obligor or child residing outside the United States.
 - (5) "Foreign support agreement" means:
 - (a) An agreement for support in a record that:
- (A) Is enforceable as a support order in the country of origin; 31

1 **(B) Has been:**

- 2 (i) Formally drawn up or registered as an authentic instrument by 3 a foreign tribunal; or
- 4 (ii) Authenticated by, or concluded, registered or filed with a for-5 eign tribunal; and
- 6 (C) May be reviewed and modified by a foreign tribunal; and
- (b) A maintenance arrangement or authentic instrument under the
 8 Convention.
- 9 (6) "United States central authority" means the Secretary of the 10 United States Department of Health and Human Services.
- SECTION 63. Sections 62 to 74 of this 2015 Act apply only to a support proceeding under the Convention. In such a proceeding, if a provision of sections 62 to 74 of this 2015 Act is inconsistent with sections 2 to 61 of this 2015 Act, sections 62 to 74 of this 2015 Act control.
- SECTION 64. The governmental entity of this state is recognized as the agency designated by the United States central authority to perform specific functions under the Convention.
- SECTION 65. (1) In a support proceeding under sections 62 to 74 of this 2015 Act, the governmental entity of this state shall:

- (b) Initiate or facilitate the institution of a proceeding regarding an application in a tribunal of this state.

ARTICLE 8

(Interstate Rendition)

- SECTION 75. (1) For purposes of this section and section 76 of this 2015 Act, "governor" includes an individual performing the functions of governor or the executive authority of a state covered by this chapter.
 - (2) The Governor of this state may:
- (a) Demand that the governor of another state surrender an individual found in the other state who is charged criminally in this state with having failed to provide for the support of an obligee; or
- (b) On the demand of the governor of another state, surrender an individual found in this state who is charged criminally in the other state with having failed to provide for the support of an obligee.
- (3) A provision for extradition of individuals not inconsistent with this chapter applies to the demand even if the individual whose surrender is demanded was not in the demanding state when the crime was allegedly committed and has not fled therefrom.
- SECTION 76. (1) Before making a demand that the governor of another state surrender an individual charged criminally in this state with having failed to provide for the support of an obligee, the Governor of this state may require a prosecutor of this state to demonstrate that at least 60 days previously the obligee had initiated proceedings for support pursuant to this chapter or that the proceeding would be of no avail.
 - (2) If, under this chapter or a law substantially similar to this

chapter, the governor of another state makes a demand that the Governor of this state surrender an individual charged criminally in that state with having failed to provide for the support of a child or other individual to whom a duty of support is owed, the Governor of this state may require a prosecutor to investigate the demand and report whether a proceeding for support has been initiated or would be effective. If it appears that a proceeding would be effective but has not been initiated, the Governor of this state may delay honoring the demand for a reasonable time to permit the initiation of a proceeding.

(3) If a proceeding for support has been initiated and the individual whose rendition is demanded prevails, the Governor of this state may decline to honor the demand. If the petitioner prevails and the individual whose rendition is demanded is subject to a support order, the Governor of this state may decline to honor the demand if the individual is complying with the support order.

ARTICLE 9

(Miscellaneous Provisions)

SECTION 77. In applying and construing this uniform act, consideration must be given to the need to promote uniformity of the law with respect to its subject matter among states that enact it.

SECTION 78. This chapter applies to proceedings begun on or after the effective date of this chapter to establish a support order or determine parentage of a child or to register, recognize, enforce or modify a prior support order, determination or agreement, whenever issued or entered.

SECTION 79. If any provision of this chapter or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this chapter that can be given effect without the invalid provision or application, and to this end the

- (3) The moving party shall include with the motion a certificate regarding any pending support proceeding and any existing support order other than the order the party is moving to modify. The party shall use a certificate that is in a form prescribed by the administrator and include information required by the administrator and subsection (2) of this section.
- (4) The moving party shall serve the motion upon the obligor, the obligee, 14 the party holding the support rights and the administrator, as appropriate. 15 The nonrequesting parties must be served in the same manner as provided 16 for service of the notice and finding of financial responsibility under ORS 17 416.415 (1)(a). - (7) A motion for modification made under this section does not stay the administrator from enforcing and collecting upon the existing order unless so ordered by the court in which the order is entered.
- (8) An administrative order filed in accordance with ORS 416.440 is a final judgment as to any installment or payment of money that has accrued up to the time the nonrequesting party is served with a motion to set aside, alter or modify the judgment.
