Increases Oregon minimum wage rate in graduated steps to \$13.50 per hour by 2017.

Declares emergency, effective on passage.

- 5 **SECTION 1.** ORS 653.025 is amended to read:
- 6 653.025. (1) Except as provided by ORS 652.020 and the rules of the Com-
- 7 missioner of the Bureau of Labor and Industries issued under ORS 653.030
- 8 and 653.261, for each hour of work time that the employee is gainfully em-
- 9 ployed, no employer shall employ or agree to employ any employee at wages
- 10 computed at a rate lower than:
- 11 (a) For calendar year 1997, \$5.50.
- 12 (b) For calendar year 1998, \$6.00.
- 13 (c) For calendar years after December 31, 1998, and before January 1,
- 14 2003, \$6.50.
- 15 (d) For calendar year 2003, \$6.90.
- (e) For calendar years [after 2003] 2004 through 2015 and for calendar
- 17 **years after 2017**, a rate adjusted for inflation.
- 18 **(f) For calendar year 2016, \$11.40.**
- 19 **(g) For calendar year 2017, \$13.50.**
- 20 (2)(a) The Oregon minimum wage shall be adjusted annually for inflation,

- 1 as provided in paragraph (b) of this subsection.
- (b) No later than September 30 of each year, beginning in calendar year 2
- 2003, the commissioner shall calculate an adjustment of the wage amount 3
- specified in subsection (1) of this section based upon the increase, if any, 4
- [(if any)] from August of the preceding year to August of the year in which 5
- the calculation is made in the U.S. City Average Consumer Price Index for 6
- All Urban Consumers for All Items as prepared by the Bureau of Labor 7
- Statistics of the United States Department of Labor or its successor. 8
- (c) The wage amount established under this subsection shall: 9
- (A) Be rounded to the nearest five cents; and 10
- (B) Become effective as the new Oregon minimum wage, replacing the 11 12 dollar figure specified in subsection (1) of this section, on January 1 of the
