What Does PSRB Do?

- Supervise those adults and youth who assert the insanity defense to a charge in criminal court
 - Guilty Except for Insanity (GEI)
 - Responsible Except for Insanity (REI)
- Supervise those adults who have a mental illness resistant to treatment who need supervision and monitoring (2013 SB 421)
- Conduct Relief Hearings for those who request restoration of firearm privileges due to a civil commitment (2009 HB 2854)
- Currently implementing a sex offender designation/relief program (2013 HB 2549)

History

- When: created in 1977 by Legislature
- Why Then: Response to perceived problem
 - Courts lack expertise/staff to monitor & supervise
 - Hospitals were not necessarily making discharge decisions with public safety in mind
- Why Now:
 - Board Supervision can help ensure therapeutic services and stability for individuals who otherwise might re-offend and enter the Department of Corrections
 - Board given additional duties because of its expertise in mental illness, risk assessment and outstanding safety record

Board comprised of Adult Panel & Juvenile Panel:

- 10 member part-time multi-disciplinary
 - 2 psychiatrists
 - 2 psychologists
 - 2 attorneys experienced in criminal practice
 - 2 parole/probation officers
 - 2 members of the general public (usually with a background in mental health)
- Virtually all Board Members maintain full-time employment
- Stipend per day is \$334
- Conduct hearings weekly over 700 last year
- 11 FTE, \$2.4 million 2013-15 Budget





Five Layer Review/Evaluation for Conditional Release

- A person will not be placed on condition release until the following proposed conditional release plan has been reviewed by:
 - Hospital treatment team
 - Hospital Risk Review Panel
 - Community Provider (Cascadia, Luke-Dorf, Columbia Care)
 - County Mental Health Agency
 - PSRB Final Approval, at a full hearing

A "Day in the Life" of a PSRB Client on CR

- 20 hrs./week structured activity provided by Community Mental Health Agencies
 - Medication management
 - Individual therapy (specialty, DBT or sex offender treatment)
 - Substance abuse/self-help groups
 - Random urinalysis testing (UA's)
 - Peer support groups
 - Skills training (public transportation, money mgt., cooking, laundry, shopping)
 - Group therapy
 - Supported Employment


Supervising and Monitoring

- Police Contact is available 24/7 through a LEDS terminal;
- Daily calls from Providers when there is a change is mental health status
- Licensed Housing Staff on-site 24/7 <u>AWAKE</u> staff; alarmed door; curfew
- Supervised Medications; Payee (no funds)
- UA's
- Some clients have "shall be supervised at all times outside the facility" as a condition
- Monthly Progress Reports/Incident Reports sent to PSRB, County and AMH

Types of residential placements available for PSRB clients

- Secure residential treatment facility (SRTF) 19%
- Residential treatment facility (RTF) 18%
- Residential treatment home (RTH) 32%
- Adult Foster Homes 8%
- Supported Housing (SH) 13%
- Independent living 23%
