## **TESTIMONY Oregon Vaccines 2015**

This committee has the opportunity to make Oregon one of the most repressive States or you can say no to SB442 and keep intact parents rights to give informed consent, and make medical decisions for their child.

Story of IMAGINE your newborn grandbaby is about to be born

- informed consent you sign in to have your baby unknowingly giving permission to
- injection of 250 mg aluminum (the adult maximum is 50 micrograms)
- Q: If you knew your newborn was not at risk (Hepatitis B sex IV drug use, mom is immune and tested not to have Hep B)
- Q if you knew that babies who get more than 5 micrograms loose developmental milestones
- Q if you knew that giving the hepatitis B has been associated with increased autism
- Q if you knew that giving the hepatitis B to infants is not giving lasting immunity.

Story of being in practice in 2001 when we moved Hep B form teens to newborns.

## Story of Noah

- one new case of autism each year (normal at 1 and fully severe autistic by 2)
- one new case / year 2003 2008

## **Leaving WESTSIDE Pediatrics**

New experience at Integrative Pediatrics 11,000 patients

200 severe autism, 1000 spectrum + ADHD

1000 now age 3+ with no new autism in those families who don't already have an autistic child. )0/1000.

What has been different – No Hep B as an infant, one aluminum vaccine at a time MMR at age 3 or older.

Compare with autism rate 1/100

Norway data – Jama 2013 article 1/1000 – no Hepatitis B vaccine.

What about this scary measles issue.

We already have in place a perfect system. If a school has a case the law already allows exclusion of those unvaccinated or who cannot prove immunity

One case a year in Oregon – no one caught measles from them Herd immunity works and it will still work if children get this vaccine at age  $3\,$  as opposed to age  $1\,$ .

You say = but the vaccine is safe IOM – report

Pedistrics 2005 article proving no link

Hooker article – same data – 300% increase in autism in African American boys who got the MMR before age 3

Thompson CDC – data was intentionally excluded not following study guidelines

How would you like to sell and market a medical procedure that everyone has to get, and even if it causes harm you have no liability? What if you could get that product mandated – forced on every child born in America?

This is where we are headed with this misguided bill. Please vote no and put science back into the debate, and reject the further erosion of parents rights to make medical decisions for their children.

We are entering personal medicine world. Do you know if you have the MTHFR defect? 30-50% of us have this and when we do our children are at far higher risk of getting autism when exposed to toxins and vaccines, too early in life.
