Chair ----- and members of the committee:

My name is Ashley Buckle, and I live in Keizer, OR. Im hear today representing HB 2356 regarding Invasion of Personal Privacy. I was victimized by my steptather, Bryan Tilley. Below is the statement I read at his sentencing that I would like to submit as testimony. Thank you.

Though it is nearly impossible to put into words the pain and fear that I experienced while being stalked by Bryan, not to mention the ongoing list of crimes that he committed, here is a brief description. During my senior year of college, I was stalked over the internet, not knowing who the stalker was. My facebook, twitter, instagram, email, cell phone, and computer were all compromised and were used by my stalker to post threatening and unwanted pictures and statements without my consent. Once we found out that my stepfather was my stalker, we discovered several videos from hidden cameras in my home in Corvallis, Keizer, and other victim's homes as well. These hidden cameras were placed in bedrooms and bathrooms without us victims knowing.

Additionally, this is what I read to my step-father at his sentencing.

When I heard I had and opportunity to tell you how I feel I didn't know where to start. You have caused so much pain in my life over the past 14 months. There is no way I could explain all the pain and suffering you have caused me.

I confided in you and you convinced me your intentions were to protect me and to help me to identify my stalker. You checked in on me daily to make sure I was doing well and helped me to file police reports. You made me feel safe, protected, and reassured. When the person who stalked me was arrested, instead of relief, I learned that the last 15 years of my life was a lie. The man I called my father was solely responsible for terrorizing me. You witnessed be fearful of my safety, yet you continued to stalk and harass me.

Not only did you stalked and harass me through my social media, you also tracked me and my every move though my GPS on my cell phone. You continually controlled my life by threatening me and punishing me with embarrassing pictures on my social media. You also gained

complete power of my life by shutting my phone off numerous times so I could not get in contact with anyone and blocked many of my friends phone numbers. You instilled fear in my best friends, family, and community. You would blame me every time something went wrong and would tell me I was tearing my family apart even though you were the one causing all the pain. You were so good at lying and never thought you would get caught. I was afraid to open my front door every morning to start my day. I should have never had to feel that way. No one should be afraid to leave their house worrying that something might happen to them. You destroyed so many of my friendships and tried to convince me everyone was an awful person.

Not only did you stalk me, but you placed hidden cameras in my bedroom and bathroom in my home in Keizer and my apartment in Corvallis. The fact you think you have the right to watch me in my bedroom and bathroom proves what kind of person you truly are. No father should want to watch their daughter shower and get undressed. Not only did you think you had the right to my privacy, but you also filmed other women. You have NO right to watch other people in their bedrooms and bathrooms.

You may have caused me, my friends, my family, and my community pain, but I am the one who gets to walk free today. I have such an amazing support system and because of this I am a stronger. I am now in the process in trying to change laws so people like you can't victimize others without a serious punishment.
