

COOL SCHOOLS PHASE 5

K-12 Public Schools Energy Efficiency Projects Opportunity Announcement January 16, 2015

The Oregon Department of Energy invites all K-12 public school districts to register for this latest Cool Schools opportunity. School districts interested in increasing energy efficiency, reducing energy use, reducing energy costs, and enhancing learning environments in school facilities are encouraged to take advantage of the latest offerings.

A special one-time grant of up to \$400,000 will be available to K-12 public school districts to implement deep energy retrofits in order to achieve substantial savings, reduce their cost of energy, and improve the learning environment at kindergarten through 12th grade (K-12) facilities.

Phase 5 will continue to offer business and technical assistance to K-12 public school districts currently planning for energy efficiency and energy saving projects (see below for more details). School districts with existing energy saving projects identified through prior phases of Cool Schools are encouraged to apply.

GRANT OPPORTUNITY

- Total grant funding of up to \$400,000 is available for deep energy retrofit projects in school facilities. Total available grant funding (\$400,000) may be awarded to one or more projects.
- Potential retrofit projects may address: space condition and water heating, ventilation, lighting, thermal envelope, alternative energy systems, retrofitting school bus fleets, alternative energy systems and other projects designed to increase the efficiency of energy using systems in K-12 public schools.
- Focus on instructional facilities.

Cool Schools is a voluntary four-year pilot designed to accelerate energy efficiency investments in all of Oregon's 197 public schools districts. The initiative provides a combination of technical and business assistance, and leverages financial resources such as the Small-scale Energy Loan Program, to support project development. Cool Schools is a complementary effort for the public schools in PGE and Pacific Power territory that receive public purpose charge funds for required energy audits and measures.
