## Director's Report

Michael Kaplan, Acting Director

- Budget
  - The Agency Request Budget (ARB) was submitted the beginning of August.
  - This budget, as proposed to the Governor's Office, will resize the Oregon Department of Energy (ODOE) to align agency mission to FTE count.
  - ODOE is proud of the proposed budget as it reflects changes to the agency and priorities moving forward.
- Business Energy Tax Credit (BETC)
  - Testimony regarding BETC on August 27, 2014 was honest and critical, when necessary.
  - The Legislature appreciated hearing the message.
  - This brings to a close a 35-year program for ODOE.
- Role of Energy Advisory Work Group (EAWG)
  - The group agreed a charter would be helpful to explicitly identity the role of EAWG and the goals of what its members hope to accomplish.
  - The charter will address the role of the group as related to Governor Kitzhaber and his staff, ODOE, and among group members.
  - Brendan McCarthy from Portland General Electric (PGE) commented that the charter should capture the concerns of <u>HB2807</u>.

#### Governor's Report

Margi Hoffman, Governor's Policy Advisor

- ODOE Director Search
  - The search for the next Director of ODOE is ongoing and active (as of the date of the meeting, September 2, 2014).
  - The search is seeking candidates for recommendation to Governor Kitzhaber and stakeholders.
  - There are three potential candidates for the position (as of September 2, 2014); the target date of hire is October 1, 2014.
- EPA's Clean Power Plan Proposed Rule (111D)
  - There are three agencies preparing comments on the Rule by October 16, 2014 and Oregon's comments are taking into consideration feedback from stakeholders.

- Although other states are pushing for an extended comment period, Oregon is planning to meet the current deadline. Additional comments should be shared with Ms. Hoffman as soon as possible.
- Governor's Recommended Budget (GRB)
  - The GRB will be released on December 1, which takes into account the ARB.
  - If stakeholders see things that fall outside the ARB, provide comments to Ms. Hoffman by October 15, 2014.

## **ODOE** Legislative Concepts

# 2015-17 Budget

- Budget Process
  - The budget is biennial and the process requires one year to complete.
  - Each agency submits an Agency Request Budget (ARB) by August 1.
  - Governor Kitzhaber presents a balanced, Governor's Request Budget (GRB) by December 1.
  - The Legislature presents the Legislatively Adopted Budget (LAB) by June 30.
  - The LAB is the basis for the next biennium's budget.
- Goals of ODOE ARB Development
  - The top priority of ODOE's budget development process was to adequately and appropriately resize the agency.
  - Temporary reductions were made permanent.
  - ODOE is realigning resources to ensure stable funding is available for the Planning,
    Policy and Technical Analysis and Facilities Siting groups, while allowing ample resources for the energy tax credit, state energy loan, and radioactive waste protection programs.
- Bottom line budget: \$203 million
  - \$10 million from ODOE budget to Clean Energy Works of Oregon

# EPA's Clean Power Plan Proposed Rule (111D)

- Oregon DEQ is the lead agency in preparing comments on behalf of the State of Oregon for EPA's new proposed rule for existing power plants. ODOE is actively involved in the process.
- The rule applies to 2012 data and the first compliance obligation begins in 2020. The final compliance obligation is 2030 and beyond.
- Oregon will submit comments by the current deadline, October 16. The final rule is anticipated in June 2015.

# Strategic Plan Update
