1. I completed my initial laser training at the University of California, Irvine Campus, The Beckman Laser Institute presented by the American Society for Laser Medicine and Surgery, Inc. or "ASLMS", on November 7th, 2010. This covered all aspects of laser from Safety to physics, and various treatment protocols. The course which was very interesting and comprehensive, was presented by several different Physicians actually doing laser work at the Beckman Institute. Our business has been affiliated with the ASLMS since that time, being members and receiving their monthly magazine.
2. I successfully completed training on 10/16/2010, on "Cutera Xeo Platform" utilizing IPL's and Yag Laser, and have performed thousands of laser hair removal and other IPL treatments with the machine.
3. I have successfully completed training on 5/12/2011, for "Candella's Gentle Lase" utilizing an Alexandrite crystal laser. It is the machine we most often use for Laser Hair removal on skin types 4 and below. And I have done more than 5400 treatments on this machine alone.
