Dear Co-Chars Devlin and Rayfield,

Thank you for the opportunity to continue the discussion of the Oregon Department of Agriculture (ODA) and the implementation of the agency's programs.

Below is the department's response to two questions raised during Day 2 of the agency's budget presentation.

Regarding the Wolf Compensation Program, how many federal dollars has the agency received for this program?

In the 2011-13 biennium, ODA established and implemented the Wolf Depredation Compensation and Financial Assistance Grant Program (WDCFAGP) using \$100,000 of appropriated general funds. During the 2013-15 biennium, the department also received an additional \$100,000 for the program, totaling \$200,000. This was a one-time appropriation. State dollars appropriated to WDCFAGP have been used to leverage federal funds.

In 2013, ODA received a total of \$63,125 from the US Fish and Wildlife Services, Wolf-Livestock Demonstration Grant Fund¹. Allocation of these federal funds is as follows:

- \$11,250 for direct compensation to producers for death or injury to livestock
- \$51,875 for prevention techniques

In 2014, ODA received a total of \$53,000 from the same federal grant². All of the money from this federal grant is to be used for prevention techniques.

I would like to add that all federal grant dollars require a 50 percent match of state dollars.
