SUMMARY

Requires that fitness determination be conducted before hiring individuals with specified criminal history if individual will have direct contact with resident of residential facility or adult foster home or persons who receive in-home services or supports.

Declares emergency, effective on passage.

- [(4)] (5) If the criminal background check conducted by a home health agency or in-home care agency under subsection (2) of this section reveals that the individual who is subject to the criminal background check has been convicted of any of the crimes described in subsection (3) or (4) of this section, the home health agency or in-home care agency may not employ the individual.
- [(5)] (6) Public funds may not be used to support, in whole or in part, the employment, in any capacity having contact with a recipient of support services or a resident of a residential facility or an adult foster home, of a mental health or substance abuse treatment provider who has been convicted of committing, or convicted of an attempt, conspiracy or solicitation to commit, a crime described in ORS 163.095, 163.115, 163.375, 163.405, 163.411 or 163.427.
- [(6)] (7) Upon the request of a mental health or substance abuse treatment provider, the department or authority shall maintain a record of the results of any fitness determination made under ORS 181.534 (11) and (12). The department or authority may disclose the record only to a person the provider

- 26 (D) Is currently receiving or has formerly received mental health services,
- 27 or is in recovery from a substance use disorder and meets the abstinence
- 28 requirements for staff providing services in alcohol or other drug treatment
