## Nature of the Request

The Oregon Department of Justice Crime Victims' Services Division (CVSD) is eligible to apply for a new one-time non-competitive grant from the U.S. Department of Justice, Office for Victims of Crime (OVC). This grant opportunity is designated specifically for CVSD as Oregon's administering agency for the Victim of Crime Act (VOCA) grant.

This new training grant opportunity totals \$323,629. OVC allows for grants to be spent in the year of issuance plus three additional years. The deadline to submit a letter of intent is March 6, 2015. OVC operates on a federal fiscal year and if Oregon receives an award, it is anticipated the grant period would begin on October 1, 2015.

No state match is required.

# **Action Requested**

The Oregon Department of Justice requests approval to apply for the federal funds available through the Office for Victims of Crime.

#### **Purpose of the Grant**

The purpose of this new VOCA funding is to increase access to training for victim service providers across the state. CVSD proposes to use this funding in the following manner:

- Development of new state trainings to bring victim-centered, trauma informed practices to first responders and victim services providers on specific topics including the commercial sexual exploitation of children, campus sexual assault response and domestic violence.
- Increase funding for the State Victim Assistance Academy (SVAA). The increase will be used to provide scholarships for SVAA attendees, allow SVAA to hire FTE to assist their program coordinator and develop additional trainings and curriculum.
- Scholarships for victim service program directors and victim advocates to attend national training events. Many training events occur throughout the year and due to limited funding and caps on out of state travel, we have been unable to support such opportunities. Victim service professionals would be well-served from national training opportunities.

CVSD is a regular sponsor and provider of victim service training in Oregon and will be able to use this additional money to significantly increase the knowledge base of the state's victim service providers.

Dear VOCA Administrators,

I know you are aware that there was a substantial increase in the Federal Fiscal Year 2015 Crime Victims Fund appropriation level to \$2.361 billion. This increase will result in a quadrupling of VOCA assistance formula grants. We believe the increased funding will drive a greatly increased need for training and technical assistance. OVC intends to post a \$25 million noncompetitive discretionary grant solicitation for state VOCA assistance administrators to apply for funding to support training and technical assistance for all victim related training needs. This discretionary funding is more flexible in the range of training and technical assistance activities that it may support, when compared with the annual VOCA assistance formula grants. For example, State Victim Assistance Academies (SVAAs) have struggled because of insufficient funds. We encourage the use of these additional funds to enhance existing SVAAs or to establish new ones. These funds also could support statewide training initiatives, crime victim related conferences, basic training for new programs for underserved victims, and training scholarships to service providers and others who work with crime victims. As with all VOCA awards, states would have the year of award plus three years to expend these funds.

Under this solicitation, OVC anticipates that it will award a non-competitive discretionary grant to each State and territory that is eligible to receive a VOCA victim assistance formula grant. OVC expects to award each state, the District of Columbia, the U.S. Virgin Islands, and Puerto Rico a base amount of \$50,000; and the territories of Northern Mariana Islands, Guam, and American Samoa a base amount of \$20,000; plus an additional amount based on population. OVC anticipates requiring applicants to submit proposals that use the entire expected award amount. I have attached a copy of the proposed allocation table.

In order to allocate the funding, OVC needs to know whether you intend to apply for and (if approved for funding) accept this training discretionary grant.
