The number of substitute days given are best guess estimates given by district contacts.

Districts which have no high school may have a shorter school day, due to the shorter required instructional hours for elementary students.

Typically, substitute teachers' hours are similar to the students', but this doesn't allow preparation time before class starts.

Typically, the regular teachers have more planning time on student contact days than the substitutes, and their salary is not reduced from the salary on a five-day schedule.

The chart shows that in most districts there is no reduction in instructional time when schools change to the four-day week.

Schools that show the largest number of substitute teacher days in relation to the number of students probably had a long term substitute when a teacher took a leave, which, especially in the smaller schools, is a rare occurrence.
