RE: House Bill 3503

Chair Barker and members of the House Judiciary Committee, I am Jeremiah Stromberg, Assistant Director of the Community Corrections Division for the Oregon Department of Corrections (DOC). I am here to support HB 3503 and answer any questions.

What the Bill Does:

HB 3503 directs DOC to establish a Family Sentencing Alternative Pilot Program in partnership with a variety of stakeholders, including the counties and the Department of Human Services. The pilot would have two separate components: one would be a diversion program whereby eligible primary parents would be diverted from prison and serve a term of probation in order to continue their primary parenting role. The second component is an expansion of transitional leave, whereby eligible primary parents who serve their sentences in prison would receive up to six months of a transitional leave period prior to their projected release date from prison.

Background Information:

Public safety is the primary focus of DOC. We must first and foremost hold offenders accountable for their actions. Next, our goal is to reduce the likelihood that individuals will commit another crime after release. To do this, we look to what works in corrections, which is a combination of programming, education, treatment, and family connections. This is critically important because we know that without intervention, without treatment, and without education and other supports, the attitudes, beliefs and behaviors that lead to criminal behavior will continue to pass from parent to child and on to the next generations. If we are going to improve the lives of children and keep them safe and healthy, if we are going to reduce poverty, stop crime, and make communities safer, we must find effective methods of intervening in and breaking the intergenerational cycle of criminal behavior. To do that, we must look to the needs of the children of incarcerated parents.

The Family Sentencing Alternative Pilot Program does just that. Its approach allows families to receive wrap-around services that focus specifically on strengthening family bonds, building parenting skills, and addressing the underlying causes of the parent's criminality.

Specific to DOC, our agency has built a strong foundation of collaboration with our public safety partners, including county community corrections, the sheriffs, district attorneys, and non-profit

organizations. If this bill passes, we are committed to working collaboratively to ensure we continue to hold individuals accountable, while also strengthening family connections.

In addition, with the expansion of Short Term Transitional Leave through HB 3194, DOC has extensive experience in operating transitional leave programs, and would use STTL as a foundation for building in the Family Sentencing Alternative Program.

Requested Action:

In conclusion, DOC supports HB 3503, and looks forward to working in collaboration with all stakeholders on implementation should this bill pass.
