Package 801 LFO Analyst Adjustments

<u>Package Description</u> The agency's current service level calculation has an error. It does not fully fund the flexible benefits costs associated with the Executive Director position. One-third of these costs were incorrectly shifted out of the current service level, to POP 101.

POP 801 restores the funding needed to pay these expenses to the agency's current service level budget.

<u>LFO Recommendation</u> Increase the General Fund appropriation for Personal Services by \$10,212, to fully fund flexible benefits for the Executive Director position. Budget Instructions General Fund appropriation [0050/8000] : +\$10,212

General Fund Personal Services expenditures [3995/8000]: +\$10,212

The General Fund should be allocated to Flexible Benefits [3270/8000], but LFO ORBITS permissions restrict Personal Services adjustments to Account 3995.

LFO Recommendation:

Approve the Key Performance Measures and KPM targets shown above. The KPMs are unchanged from the 2013-15 biennium. The agency did not propose KPM targets for KPMs #1, #2, #3, #4, and #6. LFO recommends approving the identified targets, which are equal to the KPM targets established for the 2013-15 biennium. LFO notes that minimal KPM data exist for this agency. The Commission is easily able to track all KPMs, excluding KPM #5, however, the agency did not report data on KPM #6, and the low number of prosecutions and of cases submitted to the Supreme Court means that the most recent data for KPMs #1 through #4 date back to 2008. The most recent data for KPM #6 also dates back to 2008.
