## Written Testimony regarding House Bill 3500 and Open Primaries in General

Chair Hoyle, Vice-Chairs Smith Warner and Gilliam, and Members of the Committee,

First, thank you for including OACC in your discussion regarding the "Open Primary" concept.

As County Clerks and Election Officials, this is a subject that we are keenly interested in, and we would be happy to give you our input on any and all concepts you might be considering.

As I'm sure you know, this concept has been discussed during prior legislative sessions. While OACC is not inherently opposed to the idea of conducting Open Primary elections, we do have some concerns that we would like to bring to the table.

- 1) Cost: Counties all across Oregon are in a tough financial spot. It is important to keep that reality at the forefront of the discussion.
- 2) Simplicity: Vote by mail is a remarkably simple system that allows electors to vote with very little effort. Keeping the act of voting a simple and easy process is of the utmost importance.
- 3) Transparency: With simplicity comes transparency. Voters are more apt to understand and respect a transparent process.
- 4) Efficiency: Multiple handling of ballots can create inefficiencies, and sometimes security risks.
