Work Session Recommendations

Senate Bill 269 raises pilot registration, aircraft registration, and airport registration fees. The increased revenue will allow the Department of Aviation to operate at the current service level during the 2015-17 biennium, provide additional funding to Oregon Emergency Management, and provide the required 10% match to federal funds available for airport capital projects.

Fees for pilot and aircraft registration were last raised in 2007. Fees for public airport registration have been at a flat rate (\$30) since 1997. Specifically, the fee increases fund the following items:

- **Pilot registration:** the Department of Aviation does not generate sufficient revenue to allocate funds to Oregon Emergency Management, as required by ORS 837.035, to provide search and rescue services to the aviation community.
- Aircraft registration: the current fee structure no longer meets the demand for services for Federal Aviation Administration grant matching, airport operating costs, and Unmanned Aerial Vehicle registrations.
- **Public Airports Registration:** the \$30 fee currently in place does not cover the cost of services provide by the Department of Aviation for public airports, such as land use coordination with counties, development expertise, and legal and administrative costs.

9	relating to competency of the pilot and payment of a fee of [\$12] \$24 for initial registration and
10	[\$24] \$48 for each renewal of registration shall be the requisite for registration of the pilot under
11	ORS 837.020. A filing of a written statement containing the information reasonably required by the
12	Oregon Department of Aviation is sufficient to effect a registration. No originals or copies of federal
13	certificates, permits, ratings or licenses shall be required of the applicant. Duplicate certificates of
14	pilot registration may be obtained upon proof of loss or destruction of the original by application
15	to the department and the payment of \$5 for each additional certificate.
16	(2) The department may issue certificates of registration and may prescribe requirements for
17	possession and exhibition of such certificates.
18	(3) Information submitted in any application for registration is a public record and is open to
19	public inspection during normal office hours.
