Randy,

I was sent a copy of the email Lewanda wrote to some of the BE Managers regarding the organizational meeting of the OABM. Subsequently, I was sent your response. I am now responding to your email to Lewanda.

This correspondence was not in any way meant to be considered the business of the Oregon BEP, but rather the official business of the National Federation of the Blind of Oregon. You may recall that the NFBO is an organization to which you have been denied membership. It would have been absurd for Lewanda to have sent this email to you, as you are not invited to be involved in the Oregon Association of Blind Merchants. Furthermore, we are under no obligation whatever, to include all managers in our correspondence, regardless of its content.

If it displeases you to be "singled out" like this, perhaps you might reflect on your conduct and the reasons you are currently not permitted to be a member of the NFBO. The only way that we would consider sending you NFBO correspondence is if the NFBO Board of Directors received and granted a request from you, asking that we reconsider your eligibility for membership. This has not occurred, and therefore we are not going to send organizational correspondence your way.

Finally, I find this whole situation to be an exercise in futility. There is little doubt in my mind that if Lewanda had sent you that email, you would have come after her in similar fashion, for harassing you with information about an organization you have no intention of joining.

All this having been said, I trust that you will come to understand that the BE Managers can be involved in things other than Oregon BEP Business, and that sometimes, you are going to be left out of that equation. I also trust that you will discontinue this effort to bully the members of the National Federation of the Blind of Oregon as they go about

their business to build and sustain the Federation. I am not holding my breath on the the latter, given your character and patterns of behavior, but one can always hope.
