

**PROPOSED AMENDMENTS TO
HOUSE BILL 2465**

1 On page 1 of the printed bill, line 3, delete “, 807.160”.

2 Delete lines 8 through 27.

3 On page 2, delete lines 1 through 30.

4 In line 31, delete “2” and insert “1”.

5 On page 3, line 2, restore “shall” and delete “may”.

6 In line 5, restore “shall” and delete “may”.

7 In line 8, after the period insert “Verification of proof of address may
8 include, but is not limited to, providing a utility bill, a tax return, a record
9 from a financial institution, a proof of insurance card or a health benefits
10 card, a selective service card, a mortgage document or a lease agreement.
11 The applicant may provide the proof of address by submitting proof in the
12 form of an original document or a copy of a document, use an electronic
13 device to display proof of address, or provide proof through the use of a third
14 party address verification system.”.

15 In lines 35 through 42, delete the boldfaced material and restore the
16 bracketed material.

17 On page 4, delete lines 35 through 45.

18 On page 5, delete lines 1 through 14 and insert:

19 **“SECTION 2.** ORS 807.066 is amended to read:

20 “807.066. (1) **Subject to subsection (2) of this section**, the Department
21 of Transportation [*shall*] **may** not issue driving privileges to a person who
22 is under 18 years of age unless [*the person*]:

1 “[(1)] (a) **The person** has graduated from high school and provides the
2 department with proof of graduation satisfactory to the department;

3 “[(2)] (b) **The person** has received a General Educational Development
4 (GED) certificate from a community college and provides the department
5 with proof of the certificate satisfactory to the department; **or**

6 “[(3)] (c) [*Provides the department with a form provided by the department
7 and signed by the principal, or the designee of the principal, of the secondary
8 school attended by the person that declares*] **The person’s parent or legal
9 guardian certifies** that the person is:

10 “(A) Enrolled in a [*secondary*] school of this state, or any other state **or
11 any other country;**

12 “[(4) *Provides the department with a form provided by the department and
13 signed by the authorized representative of the community college attended by
14 the person that declares that the person is*]

15 “(B) **Enrolled in a community college and** making satisfactory
16 progress toward a General Educational Development (GED) certificate **or
17 high school diploma;**

18 “[(5) *Provides the department with a form provided by the department and
19 signed by the authorized representative of the community college attended by
20 the person that declares that the person is making satisfactory progress toward
21 a high school diploma;*]

22 “[(6) *Provides the department with a form provided by the department and
23 signed by the authorized representative of the education service district or
24 school district having jurisdiction over the area of the person’s residence that
25 declares that the person is*]

26 “(C) Being taught by a private teacher, **legal guardian** or parent in
27 compliance with ORS 339.035;

28 “[(7) *Provides the department with documentation satisfactory to the de-
29 partment that indicates that the person is*]

30 “(D) Exempted from school attendance requirements due to circumstances

1 beyond the control of the person; or

2 “[(8) Provides the department with documentation satisfactory to the de-
3 partment that the person is]

4 “(E) Exempt under ORS 339.030 (2) from the requirement to attend school.

5 “(2) **The department may not issue driving privileges to a person**
6 **who is under 18 years of age and whose driving privileges are sus-**
7 **sended under ORS 809.423 (3) for withdrawing from school unless the**
8 **person:**

9 “(a) **Has graduated from high school and provides the department**
10 **with proof of graduation satisfactory to the department;**

11 “(b) **Has received a General Educational Development (GED) cer-**
12 **tificate from a community college and provides the department with**
13 **proof of the certificate satisfactory to the department;**

14 “(c) **Provides the department with a form provided by the depart-**
15 **ment and signed by the principal, or the designee of the principal, of**
16 **the school attended by the person that declares that the person is en-**
17 **rolled in a school of this state, or any other state or any other coun-**
18 **try;**

19 “(d) **Provides the department with a form provided by the depart-**
20 **ment and signed by the authorized representative of the community**
21 **college attended by the person that declares that the person is making**
22 **satisfactory progress toward a General Educational Development**
23 **(GED) certificate;**

24 “(e) **Provides the department with a form provided by the depart-**
25 **ment and signed by the authorized representative of the community**
26 **college attended by the person that declares that the person is making**
27 **satisfactory progress toward a high school diploma;**

28 “(f) **Provides the department with a form provided by the depart-**
29 **ment and signed by the authorized representative of the education**
30 **service district or school district having jurisdiction over the area of**

1 **the person’s residence that declares that the person is being taught**
2 **by a private teacher, legal guardian or parent in compliance with ORS**
3 **339.035;**

4 **“(g) Provides the department with documentation satisfactory to**
5 **the department that indicates that the person is exempted from school**
6 **attendance requirements due to circumstances beyond the control of**
7 **the person; or**

8 **“(h) Provides the department with documentation satisfactory to**
9 **the department that the person is exempt under ORS 339.030 (2) from**
10 **the requirement to attend school.”.**

11 In line 15, delete “4” and insert “3”.

12 In line 36, delete “5” and insert “4”.

13 On page 6, line 22, delete “6” and insert “5”.

14 On page 7, line 35, delete “7” and insert “6”.

15 In line 43, restore “shall” and delete “may”.

16 In line 45, after the period insert “Verification of proof of address may
17 include, but is not limited to, providing a utility bill, a tax return, a record
18 from a financial institution, a proof of insurance card or a health benefits
19 card, a selective service card, a mortgage document or a lease agreement.
20 The applicant may provide the proof of address by submitting proof in the
21 form of an original document, a copy of a document or use an electronic
22 device to display proof of address, or provide proof through the use of a third
23 party address verification system.”.

24 On page 8, line 17, delete “8” and insert “7”.

25 In line 26, restore “shall” and delete “may”.

26 In line 28, after the period insert “Verification of proof of address may
27 include, but is not limited to, providing a utility bill, a tax return, a record
28 from a financial institution, a proof of insurance card or a health benefits
29 card, a selective service card, a mortgage document or a lease agreement.
30 The applicant may provide the proof of address by submitting proof in the

1 form of an original document or a copy of a document, use an electronic
2 device to display proof of address, or provide proof through the use of a third
3 party address verification system.”.

4 In line 45, delete “9” and insert “8”.

5 On page 9, line 25, restore “shall” and delete “may”.

6 In line 28, after the period insert “Verification of proof of address may
7 include, but is not limited to, providing a utility bill, a tax return, a record
8 from a financial institution, a proof of insurance card or a health benefits
9 card, a selective service card, a mortgage document or a lease agreement.
10 The applicant may provide the proof of address by submitting proof in the
11 form of an original document or a copy of a document, use an electronic
12 device to display proof of address, or provide proof through the use of a third
13 party address verification system.”.

14 In line 32, delete “10” and insert “9”.
