

# Please Support Special Education Disclosure and Timely IEP Evaluations – HB2673

Dear Oregon Legislators,

We are writing to urge you to support HB2673, which will:

- Require schools to provide parents with an annual summary of the special education and related services provided by the district during the previous year
- Prohibit schools from forcing parents into “confidentiality agreements” whereby they can’t tell other parents what special education services they are receiving
- Require schools to complete evaluation of student eligibility for special education services in 60 calendar days – current wait times can reach 5 months or more
