I am writing you today to express support for the Oregon IDA Initiative and House Bill 2011. This year, we have an opportunity to continue on our great tradition of providing IDAs to those from modest financial means. We also have the opportunity to expand our impact around the great state of Oregon.

At MercyCorps Northwest, we focus primarily on microenterprise IDAs, but also work with formerly incarcerated individuals (both adults and those currently with Oregon Youth Authority) to provide them education IDAs for future schooling and vocational training.

Today, I wanted to provide some brief snapshots of our microenterprise IDA clients to help illustrate the Oregonians benefitting from this support.

Our clients are far ranging, from contractors to web designers, janitorial businesses to farmers, and food carts to fitness industry professionals. We work with small business owners and aspiring entrepreneurs to help get them the training and equipment they need to start or expand their enterprise.

You will see in the additional pages some pictures of recent clients who have completed our Foundations Business courses, seminars, and 1 on 1 advising. They have also completed business plans and goal setting activities on how to drive revenue and profitability for their venture. Lastly, they hit their savings goal and were matched with funds to purchase hard assets for their purchase. In some of the pictures, you can even see their asset purchases.

Thank you so much for your time and work on this Initiative. I have seen firsthand the benefits to small businesses across Oregon, who are the backbone of our economy and contribute significantly to our local communities. IDAs are a great way to support our local economy and those who run the small businesses we love.
