The International Action Network on Small Arms is the global movement against gun violence, linking civil society organisations working to stop the proliferation and misuse of small arms and light weapons. IANSA supports efforts to make people safer by reducing demand for such weapons, improving firearm regulation and strengthening controls on arms transfers. Through research, advocacy and campaigning, IANSA members are promoting local, national, regional and global measures to strengthen human security.

(IANSA Mission Statement)

As members of IANSA, we value the strength we can have together, we each value the contributions that others are making, and we are therefore committed to playing our own part in the international action network to further IANSA's mission. Each of us has a crucial role to play: in our local arena, in working with others to influence national laws and regional agreements, or through our collective work in the international network pressing for strong global treaties.

As IANSA members, we recognise that to have the impact we want on gun violence, we must work effectively together. This Charter defines our expectations of ourselves, and of others, to make this possible.

Taking action in our own arena

Our IANSA mission will be achieved if we all play our own part, in the arena appropriate to our organisation.

We are committed to

- Taking action on gun control issues in the local/national/regional/global arena appropriate to our own organisation's mandate and capabilities
- Respecting the contributions, actions and capabilities of others in the network

We expect others in the network to

- Respect our actions, and support them through solidarity if we ask for it
- Help us to strengthen ourselves through guidance and the provision of information relevant to our situation

We expect national, regional and international ANSAs to

- Help us to understand the wider context for the issues in our arena

Participation in the action network

IANSA can only be strong if we, as members, play a full part in shaping its agenda and taking action on its priorities.

We are committed to

- Participating in the forums of our national and/or regional ANSA that set national and regional priorities and policy positions
- Playing our part in the work to achieve national and/or regional ANSA priorities
- Participating in IANSA's working groups and other forums appropriate to our mandate and the issues on which we focus
- Participating in the consultative and advisory structures of IANSA through elections and consultations
- Respecting, supporting and reflecting in our own statements and work the priorities, policy positions and strategies decided in the national, regional and international forums of the action network

We expect others in the network to

- Participate alongside us

We expect national, regional and international ANSAs to

- Keep us informed of opportunities to participate
- Listen to our views and perspectives, and ensure strong consultative and collective decision-making processes

Keeping ourselves knowledgeable and informed

We can take effective action, and engage in the action network's debates, only if we know our subject well.

We are committed to

- Knowing the legal situation on small arms and light weapons in our own arena
- Respecting the knowledge and expertise of other members

We expect others in the network to

- Know the legal situation on small arms and light weapons in their arenas
- Respect our own knowledge and expertise

We expect national, regional and international ANSAs to

- Respect our own knowledge and expertise
- Inform us of any intelligence on forthcoming changes to the legal situation in our arena

Speaking for IANSA and ensuring it is respected

We can only be strong if we are seen to have a united voice. We will have the vigorous debates we need, but we will do this internally and respect collective decisions. To the outside world, we will have a consistent, united presence.

We are committed to

- Respecting decisions taken on policy and negotiating positions in legitimate forums of national, regional and international ANSAs and their working groups
- Reflecting those policy and negotiating positions when representing IANSA or parts of it to governments, inter-governmental bodies, the media and other external audiences and when formulating communications to the public

- Behaving in ways that enhance, and do not undermine, the reputation of our action network
 - Using the IANSA and ANSA brands and logos responsibly, within any guidelines set down by those responsible for their reputation
- We expect others in the network to*
- Similarly respect and reflect collective policy and negotiating positions
 - Behave in ways that enhance, and do not undermine, the reputation of our action network
 - Use the IANSA and ANSA brands and logos responsibly, within any guidelines set down by those responsible for their reputation
- We expect national, regional and international ANSAs to*
- Ensure that decision making on policy positions is responsibly and legitimately undertaken
 - Ensure that those decisions are reflected in the positions taken by all spokespeople for the action network and in all communications to the public
 - Establish, and use, mechanisms to review and take appropriate action on any cases of behaviour which may undermine the reputation of our action network

MEMORANDUM OF UNDERSTANDING

BETWEEN

THE UNITED NATIONS

AND

THE INTERNATIONAL ACTION NETWORK ON SMALL ARMS (IANSA)
ON COOPERATION AND CAPACITY BUILDING REGARDING JOINT ISSUES OF INTEREST

The United Nations, represented by the United Nations Office for Disarmament Affairs (hereinafter referred to as "UNODA"), on the one hand,

and

the International Action Network On Small Arms, headquartered in London, United Kingdom, (hereinafter referred to as "IANSA"), on the other hand,

hereinafter referred to jointly as "the Parties" and each as a "Party",

WHEREAS, under the authority delegated to it by the Secretary-General pursuant to the Secretary-General's bulletin ST/SGB/2008/8 of 27 June 2008, UNODA is entrusted with the responsibility to cooperate in the field of disarmament with organizations of the United Nations system and other organizations;

WHEREAS IANSA is created to facilitate international NGO action that is fundamentally aimed at enhancing the security of persons by preventing the uncontrolled proliferation and misuse of small arms;

WHEREAS IANSA is the designated coordinator of civil society participation in United Nations and regional meetings on small arms control, promoting the partnership with civil society mandated by the Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects,

WHEREAS the provisions of the Memorandum of Association of IANSA (2005) authorize the Executive Director to enter into suitable arrangements with other organizations and entities; and

WHEREAS the Parties have a mutual interest to promote cooperative activities in order to respond to the problem of illicit proliferation and misuse of small arms and light weapons and ammunition.

THEREFORE, the Parties have agreed as follows:

Article I
Purpose

The Parties to this Memorandum of Understanding (hereinafter referred to as "MoU") agree to formalize their cooperation and to develop joint activities with a view to reducing the illicit proliferation and misuse of small arms and light weapons and ammunition, as well as to build the capacities of civil society organizations and to strengthen the regional, sub-regional and national networks of civil society organizations on issues of arms control, disarmament, peace and security. This cooperation is to be carried out by each Party in accordance with the mandates, regulations and rules applicable to it.

Article II
Cooperation

1. The Parties undertake to closely cooperate for the realization of their shared objectives defined in this MoU.
2. The Parties agree to facilitate cooperation by developing and implementing joint programmes, projects, or initiatives that are in support of their shared objectives defined in this MoU and that are designed to improve the level of cooperation and exchange of information among them.
3. Joint activities will be implemented by the Parties through specific agreements to be entered into between the Parties in accordance with the provisions of this MoU.

Article III
Areas of Cooperation

1. The Parties undertake to cooperate in the following areas:
 - a) Develop and implement joint projects, programmes and initiatives to counter the illicit proliferation and misuse of small arms and light weapons and ammunition and to reduce and prevent armed violence;
 - b) Build the capacities of regional, sub-regional and national networks of civil society organizations;
 - c) Develop training programmes and awareness-raising strategies for civil society organizations;
 - d) Promote the effective participation of civil society in relevant UN meetings and in regional, sub-regional and national debates;
 - e) Mainstream gender and diversity issues in their joint activities.
2. The Parties undertake to cooperate in other areas of common interest in the field of arms control, disarmament, peace and security through mutual agreement and in consultation with each other.

Article IV
Consultation

The Parties agree to consult periodically, as required, on matters of mutual interest with a view to assisting each other in achieving their respective objectives in the areas of addressing the problem of illicit proliferation and misuse of small arms and light weapons and ammunition and related activities, as well as strengthening the capacities of civil society organizations to deal with these issues, and, where appropriate, to coordinate activities to this end. A written record of the proceedings and decisions reached in the consultations will be adopted when agreed by the Parties and maintained.

Article V
Participation

1. This MoU sets out a framework for cooperation by the Parties and does not obligate any funds. The duly appointed representatives of the Parties will hold preliminary discussions and exchange correspondence on initiating projects and any associated funding or cost through specific cooperation agreements and/or reimbursable agreements. Specific projects once identified will be subject to the approval of both UNODA and IANSA and agreed to in accordance with their respective organization's rules and regulations.

2. Nothing in this MoU shall obligate either of the Parties to expend appropriations or enter into any contract, agreement or other obligation except as they may mutually agree in writing.

3. The collaboration of the Parties under this MOU will be on a non-exclusive basis. Therefore, this MoU in no way restricts either of the Parties from participating in similar arrangements or agreements, including the pursuit of project funding, with other public agencies, non-profit organizations or individuals

Article VI
Responsible officials

1. The designated representatives of the Parties responsible for implementation of this MoU and receiving notice hereunder are:

2. Either Party may change its designated representative under this Article by giving advance written notice to the other.

3. Any notice or request under this MOU shall be in writing and shall be deemed to have been delivered when it is delivered by mail, e-mail, or facsimile to the designated representative of the Parties set out in paragraph one above.

Article VII
Dispute resolution

The Parties shall attempt to resolve amicably any disputes arising in relation to the interpretation and/or implementation of this MoU. More detailed dispute mechanisms, which may include arbitration under the UNCITRAL Arbitration Rules, shall be provided in the specific agreements entered into between the Parties in accordance with the provisions of Articles II and V above.

Article VIII
Privileges and Immunities

Nothing in or relating to this MoU shall be deemed a waiver, express or implied, of any of the privileges and immunities of the United Nations, including its subsidiary organs.

Article IX
Entry into force, amendments and duration

1. The MoU shall enter into force upon signature by the duly authorized representatives of the Parties.

2. The MoU may be amended by mutual consent of the Parties expressed in writing.
3. Either Party may suspend or terminate the present MoU by giving thirty (30) days' written notice to the other Party.
4. The Parties shall consult on the validity or duration of projects the implementation of which may be affected by the suspension or termination of this MoU. Termination of this MoU, however, shall not affect the obligations assumed by either Party through binding legal commitments prior to receipt of a notice of termination concerning projects or activities in effect, pursuant to individual project agreements referred to in Articles II and V 1
5. IANSA shall not assign this MoU or any of its rights, interests or obligations under this MoU without the prior written consent of UNODA.



The **International Action Network on Small Arms** (IANSA) is an international non-governmental organisation recognised by the United Nations.^[1] IANSA is the global movement against gun violence, linking civil society organisations working to stop the proliferation and misuse of small arms and light weapons. IANSA supports efforts to make people safer by reducing demand for such weapons, improving firearms regulation and strengthening controls on arms transfers. The network has over 250 full members that undertake research, advocacy and campaigning to promote local, national, regional and global measures to strengthen human security.^[2]

IANSA's Women's Network is the only international network focused on the connections between gender, women's rights, small arms and armed violence.^[3]

United Nations Activities

IANSA was involved in lobbying the 2001 United Nations Conference on the Illicit Trade in Small Arms which produced an agreed programme of action.^[4] A UN Review Conference ended in July 2006 [2] (<http://www.un.org/events/smallarms2006/index.html>) without further agreement. A subsequent meeting in 2008, agreed a substantive outcome document by a majority vote.^[3] (<http://disarmament.un.org/cab/bms3/1BMS3Pages/1thirdBMS.html>)

IANSA, part of the Control Arms Campaign, promotes an international treaty regulating the conventional arms trade. A resolution to begin work on this Arms Trade Treaty was approved by the UN General Assembly in 2006.^[5]

The US National Rifle Association says IANSA is using the treaty as the first step in a ban on private gun ownership in the United States,^[6] and also of making it easier for the world's dictatorships to oppress their own citizens.^[7] The Gun Owners of America lobbying organisation has been equally vocal in its criticism of IANSA.^[8]

Gun Control Activities

IANSA is described as an umbrella network to which almost all national and regional gun control groups belong^[9] and is estimated to represent over 800 gun control organizations in 120 countries.^[10] IANSA opposes the use of firearms for self-defense.^[9] It advocates prohibiting the private possession of many kinds of small arms, including semi-automatic rifles and handguns.^{[9][11]} It advocates that private citizens undergo a licensing process before they can possess any remaining firearms, and that legally possessed firearms be stored unloaded and away from ammunition.^[11]

National Activities

Brazil

IANSA membership in Brazil includes the groups Instituto Sou da Paz and Viva Rio^[12] which campaigned for a complete ban on civilian gun sales in Brazil.^[13] The ban was subject to a national referendum in 2005. A week before the vote, IANSA coordinated an international day of support for the Brazilian ban, with demonstrations taking place in Britain, Italy, South Africa, and other countries. IANSA urged support of the ban to "reinforce the movement in favor of gun control in other Latin American countries riddled with armed violence, and back the efforts to control private gun ownership at an international level."^[10]

The referendum was defeated by 64% of the voters.

Canada

The IANSA network includes Canadian gun control organizations such as the Coalition for Gun Control^[15]

The Coalition for Gun Control is composed of various unions and NGOs, including the Canadian Association of Chiefs of Police, the YWCA, Canadian Federation of University Women, Canadian Association of Emergency Physicians, the December 6th Foundation, Project Ploughshares, Canadian Labour Congress, Canadian Auto Workers, National Union of Public and General Employees, Big City Mayors, and others.^[16]

Recently, IANSAs lobbied against Bill C-391, which proposed to end the requirement for registration of ordinary rifles and shotguns while leaving the licensing provisions in the Firearms Act untouched.^{[17][18]}

United States of America

IANSAs membership in the United States includes gun control organizations such as the Coalition to Stop Gun Violence, Legal Community Against Violence and the Brady Campaign to Prevent Gun Violence.^[15]

IANSAs's work has been supported by funders including the Governments of Belgium, Sweden and Norway, as well as the Ford Foundation, Rockefeller Foundation, Compton Foundation, Ploughshares Fund, John D. and Catherine T. MacArthur Foundation, Samuel Rubin Foundation UNICEF, and Christian Aid.

81% of Oregonians Support Background Checks on All Gun Sales



SALEM, Ore. – Everytown for Gun Safety and the Oregon chapter of Moms Demand Action for Gun Sense in America today applauded the introduction of Senate Bill 941 (<https://olis.leg.state.or.us/liz/2015R1/Downloads/MeasureDocument/SB941/Introduced>), a bill to require background checks on all gun sales – including online sales – closing a loophole that makes it easy for convicted felons and other prohibited purchasers to get guns. Everytown also released “Officers Down,” a new analysis of FBI data available here (<http://act.everytown.org/signup/OR-Officers-Down/>), that reveals more than half of Oregon police shot to death in a 30-year span were murdered by people who were likely prohibited from possessing guns.

The new analysis also found that two-thirds of Oregon law enforcement intentionally killed in the line of duty between 1980 and 2014 were killed with guns. Of the nine Oregon law enforcement officers shot to death during this period with firearms that were not their own, at least five — 56 percent — were killed by individuals who were likely prohibited from possessing firearms.

To conduct the analysis, Everytown obtained the FBI’s Law Enforcement Officers Killed and Assaulted (LEOKA) database covering felonious deaths of law enforcement from 1980 to 2011 and updated it with additional incidents documented in media reports. For all incidents in which an officer was killed with a firearm that was not his or her own, Everytown identified the assailant and then researched state and federal criminal records and contemporaneous newspaper records to determine if the individual was prohibited by law from possessing firearms. Details of those incidents are available in the “Officers Down” analysis here (<http://act.everytown.org/signup/OR-Officers-Down/>).

Background checks are proven to help prevent crime and save lives. In states with background checks on all handgun sales, 48 percent fewer law enforcement officers are killed (<http://everytown.org/documents/2014/10/background-checks-reduce-crimes-and-save-lives.pdf>) with handguns.


As SB 941 was introduced and Everytown's analysis was released, law enforcement officials,

"Oregon's background check law has stopped thousands of criminals from getting guns in Oregon, including felons and domestic abusers. But there's a dangerous loophole in the law and killed in the line of duty," said **retired Portland Police Chief Mike Reese**. "The legislature should close this loophole. Background checks save lives."

"Today's Introduction of SB 941, background check legislation, is the first step toward keeping our kids, schools, communities—and the law enforcement officers who work to protect us—safer," said **Anneliese Davis**, a volunteer with the Oregon chapter of Moms Demand Action. "Background checks are proven to prevent gun violence—and as Oregon moms, we urge the legislature to pass this bill as swiftly as possible."

"It shouldn't be so easy for criminals to get guns. This bill would help keep guns out of the hands of dangerous people by ensuring that all Oregonians undergo the same background check when buying a gun," said **Jenna Yuille**, a gun violence survivor whose mother Cindy was killed in the 2012 Clackamas Town Center shooting. "We know stronger background checks save lives."

A national group seeking to tighten Oregon gun laws released a report Tuesday saying that the state has developed a large market for unregulated firearms sales on the Internet.

The report from Everytown for Gun Safety

(http://media.oregonlive.com/mapes/other/EGS-022_Oregon_10c_040215-FINAL.pdf)

said sellers using just four popular websites may be transferring as many as 25,000 guns a year in Oregon without conducting criminal background checks.

Everytown also conducted a sting-like operation (<http://media.oregonlive.com/mapes/other/EGS-022-Oregon-10c-040215-FINAL.pdf>) by posting 17 ads that had inquiries from 11 people with criminal records who are legally prohibited from buying firearms. Among them were two felons with a record of methamphetamine use as well as two others with domestic violence convictions.

Ted Alcorn, the group's research director, said in a statement that the report shows the need for the Legislature to pass a bill expanding background checks to cover these gun transactions in Oregon.

The state now has a "vast, dangerous marketplace, where convicted felons and domestic abusers can buy guns with no questions asked," Alcorn said.

The group, which gave \$200,000 to Democratic legislative campaigns last year, has been a major political force behind the background-check measure.

Senate Bill 941 (<http://gov.oregonlive.com/bill/2015/SB941/>), which is headed for the Senate floor, would require that transactions between private sellers be conducted in the presence of a licensed dealer who would do a background check through the Oregon State Police.

Currently, those who buy firearms from dealers or at gun shows have to submit to background checks, but those who transfer guns can skip the checks.

More than 270,000 background checks a year are conducted for Oregon gun purchases, and there has been debate about how many unchecked sales are conducted using the Internet.

Everytown's report says that a higher percentage of the prospective buyers who responded to their ads had criminal convictions than those who try to buy guns through licensed dealers and at gun shows.

However, the prospective buyers attracted by the Everytown ads may not be a representative sample of Internet buyers. For one thing, the guns listed were relatively cheap, going for \$130 or less in the examples given in the report.

Kevin Starrett of the Oregon Firearms Federation questioned the seriousness of the group's research and said it's structured to make a political point.

"It's a distraction. It doesn't mean anything to me," said Starrett, who opposes SB 941 because it would expand a background-check system he believes is seriously flawed.

Everytown released a similar study (<http://everytown.org/documents/2015/01/hiding-in-plain-sight-investigating-illegal-online-gun-sales-in-vermont.pdf>) this year for Vermont, which is also considering legislation on background checks. Everytown has received major funding from billionaire Michael Bloomberg, the former mayor of New York.

Under federal law, people are not allowed to buy firearms over the Internet without going through a licensed dealer who can conduct a background check.

However, sellers and buyers from the same state can meet on the Internet and complete their transaction in person without a background check.

Supporters of tighter gun laws say the growth of the Internet over the past two decades opened many opportunities for unregulated gun transactions.

Dan Gross, president of the Brady Campaign to Prevent Gun Violence, told the Legislature last week that his group found one Internet ad for an Oregon seller offering a Ruger 10/22 for sale with "no background check."

"All a criminal needs is an email and cash," Gross said.

Starrett said he doesn't think the Internet has opened up a large new gun market.

"I think there have always been plenty of opportunities" for private buyers and sellers to meet, he said, whether in newspapers or on bulletin boards at gun ranges.

"As Kansans and parents, we are terribly concerned about dismantling Kansas's concealed carry licensing system and we ask our lawmakers to stand up against S.B. 45," said TerriLynn Barnett Miller, a volunteer with the Kansas Chapter of Moms Demand Action for Gun Sense in America. "Forty six states, including ours, have a licensing system in place because it's just common sense that felons, domestic abusers, and people who haven't been adequately trained shouldn't be able to carry loaded guns around our children. Gun extremists had been demonstrating at Target stores in Texas, Alabama, North Carolina, Washington, Wisconsin, and Virginia in the last several months. And recently gun extremists (<http://www.motherjones.com/politics/2014/05/guns-open-carry-chilis-sonic-videos>) were told to leave Chili's and Sonic by store managers who worried for customers' safety.

Less than two months ago, Chipotle quickly responded to a Moms' petition by asking customers to leave their guns at home, "because the display of firearms in our restaurants has now created an environment that is potentially intimidating or uncomfortable for many of our customers. Later in May, Jack in the Box responded to the petition by announcing that it would enforce a prohibition of guns in its stores, stating that, "the presence of guns inside a restaurant could create an uncomfortable situation for our guests and employees and lead to unintended consequences."

Kroger Customers and Employees Speak Out: Nearly 300,000 Signatures on Petition Demanding Kroger Family Stores Prohibit Open Carry of Guns

Moms Deliver Petitions to Kroger Headquarters and Stores Nationwide; Meanwhile Kroger Employee Starts Her Own Petition and US Senators Call for #GroceriesNotGuns

This week, Moms Demand Action for Gun Sense in America will deliver nearly 300,000 petition signatures (<http://momsdemandaction.org/groceriesnotguns/>) calling on the Kroger Family of Stores to ensure the safety and security of its customers and employees by asking guests not to openly carry guns in its stores. Moms members have already made nearly 10,500 phone calls to Kroger Headquarters since August, and today members will begin dropping off petitions at Kroger, Harris Teeter, Fry's and other Kroger-owned stores in Cincinnati, Ohio – home of Kroger headquarters – as well as ones located in Arkansas, Arizona, Georgia, Indiana, Kentucky, Michigan, South Carolina, Texas and Virginia. In addition, U.S. Senators (<http://momsdemandaction.org/in-the-news/murphy-blumenthal-feinstein-urge-kroger-grocery-stores-ban-openly-carried-firearms-stores/>) and Kroger employees (<https://www.coworker.org/petitions/groceries-not-guns-at-kroger-1>) and Kroger customers have joined Moms this week in demanding Kroger to prohibit open carry of firearms in its grocery stores.

"It's well past time Kroger President & COO Rodney Ellis and CEO W. Rodney McMullen listen to their customers, employees, and elected officials and prohibit open carry inside their stores," said **Shannon Watts, founder of Moms Demand Action**. "When state laws don't protect children and families, it's up to businesses that depend heavily on female clientele to put policies in place that protect them on their private property. For moms concerned about our children's safety, that sense of security matters since millions of guns are sold every year in America without a background check and openly carried firearms are unregulated in a majority of states."

The laws in a majority of states allow people to openly carry loaded rifles in public with absolutely no training, permitting, or minimum age requirement. Combined with estimates that 6.6 million gun sales in America occur without a background check in a single year, this means that people in most states can legally carry loaded rifles in public without ever having passed a criminal background check.

Pressure on Kroger's leadership continues to grow from concerned stakeholders of all stripes, including Moms, Kroger employees and elected officials. Just this week, inspired by the Moms petition, **Mary Mueller, a 7-year Kroger employee, launched her own petition to the Kroger President and CEO circulating among Kroger employees** (<https://www.coworker.org/petitions/groceries-not-guns-at-kroger-1>). "Kroger doesn't allow guns to be openly carried in its corporate headquarters in Cincinnati. Why do they

allow it in other Kroger-owned workplaces? All Kroger employees—whether executives, managers, cashiers, or customer service representatives like me—deserve a safe workplace,"

And this past Tuesday, September 30, Senators Murphy, Blumenthal and Feinstein wrote to Kroger's President and CEO (<http://momsdemandaction.org/in-the-news/murphy-blumenthal-feinstein-urge-kroger-grocery-stores-ban-openly-carried-firearms-stores/>) urging them to

Kroger changed the grocery business by establishing in-store bakeries and deciding to sell meats in the 1900s. [...] The company has an opportunity to again be a leader. A change by Kroger, the nation's largest supermarket retailer, could have a similar effect by setting a new customer-friendly standard that other supermarkets follow."
