Subject: Local Court Report

Local Court Report

ORS 1.860 directs the Legislative Fiscal Office (LFO) to provide the Joint Committee on Ways and Means with summary data on municipal and justice courts each biennium. This statute directs the League of Oregon Cities (LOC) and the Association of Oregon Counties (AOC) to collect and supply data to LFO for this purpose. LFO is directed to identify, in consultation with LOC and AOC, the data needed relating to caseloads, revenues and expenditures.

2014 Local Court Report

LFO limited the data request for the 2014 Local Court Report to caseload, fines, and revenue distribution data. Caseload filings were requested in the following categories: civil, traffic, other violations, misdemeanors, and other. Fines imposed totals were requested for civil, traffic, other violations, misdemeanors, and other; and gross fee/fine revenues were requested for violations fines, criminal fines, and civil revenues. Finally, courts were asked to report on their revenue distributions to the state, to counties as unrestricted funds, to counties for drug and alcohol programs and jails, to counties for court facilities security accounts, and to cities. Data were requested for the 2012-13 and 2013-14 fiscal years.

The Judicial Department (OJD) maintains a registry of municipal and justice courts in the state (included as [Appendix A](#)). As of November 2014, a total of 180 local courts were registered with OJD. This total includes 145 municipal courts and 35 justice courts. OJD does not report how many of these courts adjudicate cases in a particular year.

Municipal Courts

LFO received data from 59 municipal courts (41% of the total number in the OJD local court registry). The LOC did not compile the data or provide analysis of it. LFO compiled the data into [Appendix B](#) (see page 12). The municipal court data reporting varied

considerably and was, in many cases, incomplete. Different courts use various recording systems. LFO compiled summary totals of the municipal court data, but because of variations in how municipal courts categorized their data, the figures shown in the totals table on page 12 must be viewed with caution. LFO did not receive information needed to recategorize data into the requested format, as the courts that did not categorize as requested generally did not record data as needed to do so.

The municipal courts reported 158,850 case filings for the 2012-13 fiscal year, and 164,265 case filings in 2013-14. Approximately 77% of the 2012-13 cases, and 66% of the 2013-14 cases, were for traffic violations. An average of only 170 per year were civil cases. Misdemeanor (criminal) cases are shown in the table as totaling 14,084 in 2012-13 and 13,068 in 2013-14; however, those figures are not accurate and known to be inflated, primarily because they include an unknown number of ordinance violations filed in the Eugene Municipal Court.

Justice Courts

LFO received data from 26 justice courts (74% of the total included in the OJD local court registry). The justice courts were better able to report comparable data, and provided a data summary to LFO. Justice court data are shown in Appendix C (starting on page 73). All but three of the justice courts have adopted the Majic software system to report caseload and financial data, allowing comparable data reporting across the state. The 26 justice courts reported 142,393 case filings for the 2012-13 fiscal year, and 140,346 case filings in 2013-14. Approximately 87% of the 2012-13 cases, and 85% of the 2013-14 cases, were for traffic violations. Justice courts handled a significantly higher number of civil cases than the municipal courts reported, averaging 5,500 cases per year. Misdemeanor (criminal) case filings were far below the number in the municipal courts, and totaled 1,320 in 2012-13 and 1,527 in 2013-14.

Revenues and Revenue Distributions

The distribution of municipal and justice fine revenues depends on case type and on when the violation or crime occurred. Beginning in 2012, the state established a \$60 priority payment on fine collections, to provide additional revenue to the Criminal Fine Account (CFA) to fund programs that had previously been funded by dedicated assessments outside of the CFA. When a ticket was "written" by a state trooper into a local court, the first \$60 of the fine amount collected was deposited into the CFA, and of any additional amounts collected, 50% was deposited into the CFA and the remaining 50% was retained by the county or city operating the court. For tickets issued by a local officer into a local court, the first \$60 of the fine collected was deposited into the CFA, and any additional amounts collected were retained by the local jurisdictions.

When a municipal law enforcement officer issued a citation to a municipal court, the amount in excess of the first \$60 collected was retained by the municipality. When a county law enforcement officer issued a citation to a justice court, the amount in excess of the first \$60 collected was retained by the county. In other cases, the amount collected in excess of the first \$60 was equally split between the county and municipality. Fine revenues distributed to or retained by local jurisdictions were unrestricted to use.

The distribution of municipal and justice fine revenues changed for offences committed on or after July 31, 2013. The priority payment amount to the CFA was reduced from \$60 to \$45. Amounts collected above \$45 are now distributed as the amounts collected above \$60 were previously, however, when the full amount of the imposed fine is collected, the last \$16 must be paid to the county for restricted purposes. The county must dedicate sixty percent of these revenues so received for drug and alcohol programs and for the costs of planning, operation and maintaining county juvenile and adult corrections programs and facilities; and dedicate the remaining forty percent to the county court facilities security account.

Summary

Although most municipal courts and some justice courts did not respond to the report request, the courts that did report identified that they were addressing most of the violation cases in the state. Violations (primarily traffic) cases in local courts totaled 278,733 in 2012-13 and 259,898 in 2013-14. LFO did not request data from the Judicial Department on case filings in the state circuit courts. Separately, however, OJD reports that 211,504 violation cases were filed in the circuit courts in 2012, and that 215,080 violation cases were filed in 2013. These are calendar year figures and therefore not directly comparable to the fiscal year figures reported by municipal and justice courts, however, they also reflect 12-month periods.

The data reported provide less information on misdemeanor caseloads. The reported local court criminal misdemeanor case filings totaled 15,404 in 2012-13 and 14,595 in 2013-14, though as mentioned above, these numbers are inflated for municipal courts. On the other hand, 57,529 misdemeanor cases were filed in the state's circuit courts in 2012, and 53,029 cases were filed in 2013.

Municipal courts reported imposing approximately \$23.3 million in fines for offenses in the 2012-13 fiscal year, and approximately \$21.6 million the following year. Justice court fines imposed totaled approximately \$16.7 million in the 2012-13 fiscal year and approximately \$17.1 million the following year.

Municipal courts collected approximately \$16.4 million of fine revenue in 2012-13, and \$14.9 million in 2013-14. The revenue distributions reported, however, were inconsistent with these figures, and totaled \$25.7 million in 2012-13 and \$24.5 million in 2013-14. Approximately 76% of municipal court revenues were distributed to cities, 22% to the state (CFA), 1.7% to counties on an unrestricted basis, and 0.7% to county restricted funds.

Justice courts collected approximately \$23.3 million of fine revenue in 2012-13, and \$23.9 million in 2013-14. The revenue distributions reported were comparable to these amounts. Approximately 61% of justice court revenues were distributed to counties on an unrestricted basis. The amount distributed to the state (CFA) declined from 35% in 2012-13 to 32% in 2013-14, while the amount distributed to county restricted funds increased from 1.1% to 4.4%. Distributions to cities averages about 2.6% of the total.
