Primary Care Physicians Serving Medicaid Patients in Oregon

Background These data come from the Oregon Healthcare Workforce Licensing Database. Data are collected from a number of health care professionals at the time of their license renewals.

Physicians are licensed for two years, renewing from October to December in odd-numbered year. The Office of Health Analytics receives and update to this dataset every two years.

Data presented here reflect the entire cohort of physicians working in Oregon who reported a primary care specialty at their primary work location in 2013.

Physicians in Oregon 11,099 total physicians who are licensed in Oregon, 2013

4,126 were identified as working in primary care

Primary care is defined here as those physicians who reported any of the following specialities: family medicine/practice, general practice, (general) internal medicine, pediatrics, adolescent medicine, and geriatric medicine.





Licensing data are provided here to be consistent with the earlier Dentists and Medicaid data request and reflects all licensed providers, including those for whom payer type is not applicable (e.g., providers at the VA).
