
# Oregon Health Authority Caseload Update to 2013 – 2015 Budget

Oregon Health Plan (OHP) Spring 2015 shows changes and shifts in caseload Rebalance that project \$38.4M General Fund savings.

- ✓ OHP Plus projects significant savings in the Parent/Caretaker relatives (TANF), and Aid to Blind and Disabled categories
- ✓ OHP Children's Health Insurance Program project significant savings due to a decline in monthly average eligible of <10%
- ✓ With 14 months of data under the Affordable Care Act (ACA), the monthly average change of eligible clients has increase more than 11%, generating an additional \$184M in Federal Fund expenditures for the remainder of the biennium.

## **OHA Overall Budget Risks**

#### **RATE SETTING-**

✓ OHA actuarial review of 2015, and 2016 calendar year CCO rates

#### **CASELOADS**

- ✓ Charting new territory, post-start up adjustments still necessary
- ✓ Volatility of employment in an economic recovery and people with/without access to health care
- ✓ Redeterminations and delay of closures
- ✓ Data systems for eligibility to ensure accuracy & ease enrollments

#### **REVENUES**

- ✓ Tobacco Tax revenues- history of ups and downs in forecasts
- √ Tobacco Master Settlement Agreement- changes in revenue
- ✓ DSHP- OHA relies upon AMH funding to support most of the F/F leveraging accounted for in the 2015-2017 budget [1]
