**Measure Description:**

Increases aircraft, airport, and pilot registration fees.

**Local Government Mandate:**

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

**Analysis:** This senate bill increases fees paid for aircraft registrations, pilot registrations and public use airports. The effective date of the fee increase is January 1st 2016.

The bill will raise the following aviation fees:
