### **Background Information**

HB 3499-A relates English Language Learner's (ELL) program within the Oregon Department of Education. This bill establishes two work groups or advisory groups to: (1) develop uniform budget coding requirements and reporting requirements relating to ELL spending and students; and (2) identify criteria for determining if districts meet objective and needs of ELL students, information necessary for district reporting, guidelines for district reporting, and what technical assistance is required. The bill also includes a permanent \$12.5 million distribution or "carve-out" from the State School Fund to provide funding for ELL programs and grants.

## Recommended Changes to Appropriation Bill:

The Legislative Fiscal Office recommends the –A4 amendment to the bill to remove the distribution or "carve-out" language in secion 4, chapter 25, Oregon Laws 2015 (HB 5017; State School Fund bill) passed earlier in the session which provided a one-time distribution for English Language Learners for 2015-17. HB 3499-A includes language for a permanent distribution starting in 2015-17.

#### WHAT THE MEASURE DOES:

HB 3499 establishes advisory group to develop uniform budget coding requirements and reporting requirements. This advisory group on January 2, 2016. The State Board of Education is required to adopt rules related to uniform budget coding requirements no later than January 1, 2016.

**MEASURE:** 

HB 3499 A

The bill establishes work group who is required to identify:

- criteria for determining if school district is not meeting objectives and needs of English language learner (ELL) students, or needs targeted assistance;
- information necessary for school district report on ELL student progress, with specific focus on long-term ELL students;
- technical assistance to be provided by ODE; and
- guidelines for expenditure of ELL program moneys.

The State Board of Education is to adopt rules related to above January 2016. This workgroup is also required to make specific recommendations for best practices relating to ELL students and programs as well as to determine best practices relating to specific support services. The State Board is to adopt rules on this part of the workgroup's work by January 1, 2017. The authority for the s work group sunsets on January 2, 2017.

An annual report made by each school district relating to ELL expenditures and outcomes, with first filing of report not later than September 1, 2016. The Department of Education (ODE) is required to submit biennial report to Legislative Assembly on results of ELL report.

Updates definition of ELL in statute "English as a second language" to "English language learner." and requires a statewide plan to support ELL students. ODE is directed to identify school district not meeting objectives and the needs of ELL students, or in need of targeted assistance. An account for statewide activities related to ELL programs is established which is funded with a \$12.5 distribution or carve-out from State School Fund. Declares emergency, effective July 1, 2015.

#### ISSUES DISCUSSED:

#### EFFECT OF COMMITTEE AMENDMENT:

The A-4 amendment repeals a one-time distribution language from the State School Fund for 2015-17 which was included in State School Fund bill (HB 5017) which passed earlier in the Session. Current language in HB 3499 provides for a similar permanent distribution that would include the funding for the 2015-17 biennium. FISCAL: Fiscal impact issued REVENUE: Revenue impact issued

#### BACKGROUND:

Currently, under the distribution formula for the State School Fund, students designated as belonging to "English language learning" category receive an additional 0.5 weight, for a total weighted Average Daily Membership

(ADMw) of 1.5. Within the broad category of ELL programs, there is no specific restriction, and limited reporting, around how this money may be spent.

House Bill 3499-A updates and enhances ELL programs policy by: creating a work group to address challenges to coding and budget transparency; creating a work group to examine ELL program challenges and best practices; increasing financial support for districts not meeting objectives and the needs of ELL students; increased tracking and reporting around ELL program moneys; and, creating a dedicated distribution or carve-out from the State School Fund to address ELL funding.

#### Measure Description:

Directs Department of Education to convene advisory group related to English language learner programs.

#### Government Unit(s) Affected:

Department of Education, School Districts

#### Summary of Expenditure Impact:

#### **Local Government Mandate:**

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

#### Analysis:

The bill creates the Statewide English Language Learner (ELL) Program Account for statewide activities related to English language learner programs and the account is funded by \$12.5 million distribution from the State School Fund each biennium. The State School Fund appropriation bill (HB 5017) includes the language for this distribution or "carve-out" for the 2015-17 biennium only. This bill establishes a permanent distribution for the ELL program.

The Oregon Department of Education (ODE) is directed to convene an advisory group and adopt rules related to developing uniform budget coding requirements and uniform reporting requirements to provide budget transparency for the spending of moneys received by school districts as provided by ORS 327.013. ODE is also directed to convene a work group related to the English Language Learner Program and each school district is directed to file an annual report, by September 1 of each year, related to the expenditures of the program as well as student progress information. Prior to January 1 of each odd-numbered year ODE is directed to submit to the interim Legislative Committees on Education a report on the data collected from the school districts for the preceding two school years.

To implement provisions of the bill ODE will need two (2.00 FTE) Education Program Specialist 2 positions to support research and implementation of the statewide ELL plan as well as help develop the district reports and support the targeted school districts with high concentrations of ELL's. These positions are estimated to cost \$498,334 per biennium including services and supply costs such as travel, office expenses, dues & subscriptions, as well as publicity & publications.

The remainder of the \$12.5 million is anticipated to be expended on costs such as recruitment, training, and legal costs associated with contracting school improvement coaches at each school site for 8-10 hours per week, as well as up to \$60,000/year/school grants for the ELL Program. The exact number of school districts that will be served by the ELL Program is not known but is anticipated to be between 30 to 35 schools.

**Measure Description:** Creates the Statewide English Language Learner Program Account to provide moneys for statewide activities related to English Language learner programs. Transfers to the account from the State School Fund, \$12.5 million each biennium. First applies to the 2015-16 State School Fund distribution. Takes effect on July 1, 2015.

**Impact Explanation:** HB 3499 creates the Statewide English Language Learner Program Account to provide moneys for statewide activities related to English Language learner programs. The account is funded by \$12.5 million, transferred from the State School Fund each biennium.

The funding of this account is a carve-out off the top, and reduces the amount of money available for distribution through the formula.

This \$12.5 million carve-out is included and fully accounted for in the co-chairs' State School Fund budget for the 2015-17 biennium.
