**APPOINTEE:** Martha Meeker of McMinnville; New appointment replacing Garnick

**APPOINTMENT/CONFIRMATION AUTHORITY:** ORS 835.102

**TERM:** Four-year term; July 1, 2015 – June 30, 2019

**ECONOMIC INTEREST FILING (ORS 244.050):** Not required.

**STATUTORY QUALIFICATIONS:** ORS 835.102

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members; four year terms; eligible for reappointment
  - Members appointed with consideration of the different geographic regions of the state, with one member being a resident of the area east of the Cascade Range (DALRYMPLE)
  - Not more than four members shall belong to the same political party (HUDGENS– I), (GRANATO – Non-Affiliated), (DALRYMPLE – R), (GARDINER - D), (MEEKER – Non-Affiliated), (WASHINGTON-R), (ROSENBLUM - D)
- Board membership shall represent diverse aviation interests from both the private and public sectors
- Governor appoints chair and vice-chair

**DUTIES AND AUTHORITY:** 835.015, 835.035, 835.040, 835.104

- Shall incorporate in its program a definite plan for the development of airports, state airways, airplane industries and aviation generally
- Cooperate with and assist the federal government, state municipalities, and other persons in the development of aviation activities
- May perform such acts, adopt or amend and issue such orders, rules and regulations, and make, promulgate and amend minimum standards as necessary to perform its duties
- Rules and regulations shall be in conformance with and limited as nearly as possible to federal regulations
- Meet at least once quarterly
- May provide an official seal
