TERM: Four-year term; July 1, 2015 – June 30, 2019

STATUTORY QUALIFICATIONS: **ORS 455.132 and 455.144**

- Nine members appointed to four year terms
- Members broadly representative of industries and professions involved in the development and construction of buildings and energy conservation, including:
 - An architect or engineer (**SANDOVAL**)
 - A general contractor, as defined in ORS 701.005, specializing in the construction of buildings more than three stories above grade (**GONZALEZ**)
 - A contractor specializing in construction for heavy industry (**WOOD**)
 - A representative of the building trade (**KISSELBURGH**)
 - A representative of a utility or energy supplier (**NELSON**)
 - A representative of a fire protection agency (**McMULLEN**)
 - A building official (**CARLSON**)
 - An owner or manager of a commercial office building (**SJOSTROM**)
 - A representative selected from individuals recommended by the Oregon Disabilities Commission (**WENK**)
- Members cannot serve more than two full terms of office
- Removal by Governor for “good cause.” “Good cause” includes three unexcused absences during an 12-month period

DUTIES AND AUTHORITY: **ORS 455.132, 455.144**

- Select chair and vice-chair from membership
- Will meet at least twice per year at times and places specified by the Director of the Department of Consumer and Business Services after consultation with the board, or at times and places specified by the call of a majority of the members of the board after consultation with the director.
- Assist the director of the Department of Consumer and Business Services in administering the structural, prefabricated structures and energy programs described in this chapter and the accessibility to persons with physical disabilities program described in ORS 447.210 to 447.280
