**TERM:** Unfinished four-year term: May 22, 2015 – December 31, 2019

**ECONOMIC INTEREST FILING (ORS 244.050):** Required.

**STATUTORY QUALIFICATIONS:**

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members; four year terms; serving at pleasure of Governor; one director shall be a user of transit district services; directors must reside in sub-districts; eligible for reappointment.
  - Subdistrict 1: PIERCE
  - Subdistrict 2: YEH
  - **Subdistrict 3: NORDIN**
  - Subdistrict 4: NECKER
  - Subdistrict 5: GILLESPIE
  - Subdistrict 6: WILDISH
  - Subdistrict 7: GROSSMAN
- A director whose term has expired shall continue to serve until the appointment of a successor unless discharged by the Governor.

**DUTIES AND AUTHORITY:** ORS 267.150

- Appoint general manager
- Ordinance authority
- Acquire by condemnation
- Construct and operate facilities and contract for services
- Perform duties necessary to operate mass transit system
- Provide program for transportation for disabled and physically handicapped persons
- Levy property tax
- Establish user charges, fees, and tools
- Issue general obligation revenue and refunding bonds
- Impose business, trade or occupational license fee
- Impose income tax or business tax
