**STATUTORY QUALIFICATIONS:** ORS 692.300

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- 11 members appointed to three-year terms ending on December 31:
  - Two licensed funeral service practitioners (TERRY, WOODWARD)
    - One funeral service practitioner must not offer embalming (WOODWARD)
  - One licensed embalmer (PEARSON)
  - Three representatives of cemeteries:
    - For-profit cemeteries (HENRY)
    - City/county owned or operated (DUOOS)
    - Special district owned or operated (GYURE)
  - One representative of crematorium (LOVELAND)
  - Four public members including one who is a member of a recognized senior citizen organization (CORR, GOOLSBY, JUNTUNEN, MOORE)
    - Senior citizen organization (CORR)
- Member may serve only two consecutive terms
- A board member shall be removed immediately if the member is not a resident of the state, has been absent from three consecutive board meetings, without at least one excused absence, and not licensed and good standing at time of retirement

**DUTIES AND AUTHORITY:** ORS 692.320 & ORS 692.350

- Adopt rules relating to:
  - Licensing and issuance of certificates of authority for practitioners
  - Registration of apprentices
  - Practice and operation of funeral establishments and facilities for final disposition of remains
  - Sanitary conditions for establishments and facilities where human remains are stored
- Responsible for biennial inspections of facilities and records of funeral establishment, cemeteries, and crematoriums
- The Board may hold hearings, conduct investigations, subpoena witnesses, take testimony to carry out duties
- Publish and distribute changes to statutes and rules
