DUTIES AND AUTHORITY: **ORS 390.117, 390.121, 390.124, 390.127**

- Promote policy of state toward outdoor recreation resources
- Establish policies for operation of the State Parks and Recreation Department
- Acquire real property deemed necessary for the development of state parks, roads, trails, and campgrounds
- Construct, maintain and operate facilities
- Appoint State Parks and Recreation Director
- Delegate powers and duties other than rule-making to State Parks and Recreation Director
- Adopt rules necessary to carry out its powers
- Adopt rules to assess reasonable charges for the use of areas established and maintained by the department. The commission shall report biennially to the Legislative Assembly on any fee reductions, waivers or exemptions adopted by rule
