- Elect Chair and Vice-Chair; appoint Executive Director and other employees as necessary
- License, regulate, supervise and inspect all race meets and locations. ("Race meet," as defined in ORS 462.010, means and includes any exhibition of animal racing where the mutuel system is used in conjunction with any race.)
- Prepare and promulgate rules to govern race meets
- Issue subpoenas, administer oaths, take depositions
- Cooperate with racing commissions of other jurisdictions for the betterment of racing
- Cause an annual audit to be made of the financial records of all beneficiaries of the Oregon Racing Commission Account
