**Subject:** SB 606 Relating to dental pilot project

Work Session Recommendation

\_\_\_\_\_

Senate Bill 606 extends the Dental Pilot Project established by SB 738 (2011). This 2011 legislation permitted OHA to approve, subject to available funding, pilot dental projects that encourage the development of innovative practices in oral health care delivery systems with a focus on providing care to populations that evidence-based studies have shown have the highest disease rates and the least access to dental care.

The measure previously had hearings in the Senate Committee on Health Care on 3/16/2015 and 4/6/2015.

The – A3 amendment, the original staff measure summary and the fiscal impact statement are attached to this memo, and available on the Oregon Legislative Information System (OLIS).

#### The - A3 Amendment

The -A3 amendment:

- Appropriates \$100,000 General Fund to the Oregon Health Authority.
- Requires providers of dental services in a dental pilot project approved by OHA to be eligible for reimbursement if the services are provided to a recipient of medical assistance.

# **Fiscal Impact**

Note that current statutes permit OHA to approve pilot dental projects subject to available funding. OHA will use the appropriation to establish one part-time position (0.50 FTE) to develop data collection standards and evaluation measures for dental pilot projects.

The requirement that providers of dental services in a dental pilot project approved by OHA to be eligible for reimbursement if the services are provided to a recipient of medical assistance is indeterminate because OHA does not yet know what services would be included in the pilot projects that aren't currently covered under medical assistance. In addition, it is unclear whether OHA could obtain Federal matching funds under Medicaid for these additional pilot project services. Because of federal law regarding statewide requirements, OHA would likely have to seek a waiver.

Extends dental pilot project by seven years.

#### **Local Government Mandate:**

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

## Analysis:

Senate Bill 606 with the – A3 amendment appropriates \$100,000 General Fund to the Oregon Health Authority for the 2015-17 biennium, and extends the sunset date of the Dental Pilot Project from January 2, 2018 to January 2, 2025. The bill contains an emergency clause, and takes effect on passage.

# Extension of Dental Pilot Project Program

The bill extends the Dental Pilot Project established by SB 738 (2011). This 2011 legislation permitted OHA to approve, subject to available funding, pilot dental projects that encourage the development of innovative practices in oral health care delivery systems with a focus on providing care to populations that evidence-based studies have shown have the highest disease rates and the least access to dental care. OHA received no permanent funding or position authority to carry out this work. During the 2014 Legislative Session, one-time funding of \$100,000 General Fund was appropriated to OHA to begin work on this project. In March 2014, the Dental Pilot Program Coordinator limited duration position was established. Between September 2014 and March 2015, the Dental Pilot Program Coordinator convened many stakeholders and consulted with other state pilot programs to develop a plan for Oregon's Dental Pilot Program. The program plan includes application, review and approval, monitoring, and evaluation. The program began accepting pilot project applications April 1, 2015.

Note that current statutes permit OHA to approve pilot dental projects subject to available funding. OHA will use the appropriation to establish one part-time position (0.50 FTE) to develop data collection standards and evaluation measures for dental pilot projects.

# Reimbursement of Dental Providers Participating in the Dental Pilot Project Program

The –A3 amendment requires providers of dental services in a dental pilot project approved by OHA to be eligible for reimbursement if the services are provided to a recipient of medical assistance. The reimbursement applies to all services provided on or after the effective date of this 2015 Act. The requirement that providers of dental services in a dental pilot project approved by OHA to be eligible for reimbursement if the services are provided to a recipient of medical assistance is repealed on January 2, 2025. The fiscal impact of this provision is indeterminate because OHA does not yet know what services would be included in the pilot projects that aren't currently covered under medical assistance. In addition, it is unclear whether OHA could obtain Federal matching funds under Medicaid for these additional pilot project services. Because of federal law regarding statewide requirements, OHA would likely have to seek a waiver.

#### WHAT THE MEASURE DOES:

Appropriates funds to Oregon Health Authority, for biennium beginning July 1, 2015 out of General Fund, for extending dental pilot projects. Extends dental pilot projects until 2025. Declares emergency, effective on passage.

#### **ISSUES DISCUSSED:**

- Alignment with Strategic Plan for Oral Health in Oregon: 2014-2020
- Innovative workforce model
- Access to care for underserved and disadvantaged Oregonians
- Funding for specific person to provide management and oversight of projects
- No projects have been able to start yet

#### EFFECT OF COMMITTEE AMENDMENT:

Restores language to operate pilot projects for three to five years, permitting, rather than requiring, Oregon Health Authority to approve pilot projects with certain specifications. Extends sunset from 2023 to 2025.

#### **BACKGROUND:**

Oral health is vital for sustaining overall health, getting good nutrition and communicating with others. It is an indicator of overall health and a preventative measure. Oral disease often brings disabling pain, which can worsen heart and respiratory conditions, as well as auto-immune diseases. One study in Oregon found that dental pain is a more frequent cause of emergency room visits than headache, fever and asthma. Racial, economic and geographic factors influence access to timely prevention and treatment.

The Oregon Health Authority approves dental pilot projects that intend to create innovative practices in oral health care delivery, particularly in areas of high disease rates and low access to dental care. The pilot projects operate for three to five years and evaluate factors such as quality of care and access. Projects should achieve teaching new skills to dental personnel, developing new categories of dental personnel and accelerating training of personnel. The pilot projects end in 2018.
