Secretary of State Brown:



Wednesday, June 11<sup>th</sup> 2014  
Corban University, Salem, Oregon

Invocation given at 6:15pm by Jeff Heyen. Welcome and meeting Called To Order at 6:16pm by Presiding Officer Art Robinson. Pledge of Allegiance at 6:17pm led by Mike Nearman.

Explanation of Rules at 6:18pm by Parliamentarian Tyler Smith Esq. Motion made to Adopt Rules as submitted. Unanimous Adoption of Rules by delegates.

Motion made to open Nominations from the Floor. The following Candidates were nominated: Elaine Selberg nominated Greg Astley; Rosemary Scott nominated Jan Williamson; Wayne Sellers nominated Denyc Boles; Marie Innes nominated Marcia Atkinson; Johnathon Baker nominated Mark Callahan; Elaine Selberg nominated Becky Mitts; Gordon Kelly nominated Jim Bernau; and Brad Nanke nominated Raquel Moore-Green.

Jeff Heyen was appointed Time Keeper by Presiding Officer. Rachel Lucas was appointed Secretary of the Convention. Candidates drew numbers to determine order of their speeches. All candidates gave up-to 5-minute speeches in the following order: Jan Williams, Mark Callahan, Jim Bernau, Raquel Moore-Green, Becky Mitts, Greg Astley, Marcia Atkinson, and Denyc Boles.

Presiding Officer announced at 7:08pm the commencement of Candidate Mixer. Meeting called back To Order at 7:45pm.

Credentials Report given at 7:46 pm by Credentials Chair Glenn Holum: 24 Certified PCPs eligible to vote. Election started, ballots distributed to all voting PCPs. Voting closed at 7:51pm with all paper secret ballots collected. Results of First Ballot announced at 8:05pm, Jan Williamson received a weighted majority of the votes. Results of Second Ballot announced at 8:29pm, Denyc Boles and Becky Mitts both received weighted majorities. All voting was proportional to the number of Republican voters in each Precinct.

Final Results announced at 8:29pm, with the following three candidates were nominated: Jan Williamson, Denyc Boles, and Becky Mitts. Meeting Adjourned by the Presiding Officer at 8:30 pm.
