Senate Bill 795

Sponsored by Senator WHITSETT; Senator BAERTSCHIGER JR

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Specifies that new or increased fees adopted by state agency do not become effective unless approved by Legislative Assembly by law. Applies during 2015-2017 biennium.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to state agency fees; creating new provisions; amending ORS 291.055 and section 41, chap-
3 ter 698, Oregon Laws 2013; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 291.055, as amended by section 36, chapter 698, Oregon Laws 2013, is
6 amended to read:

7 291.055. (1) Notwithstanding any other law that grants to a state agency the authority to es-
8 tablish fees, [*all new state agency fees or fee increases adopted during the period beginning on the date*
9 *of adjournment sine die of a regular session of the Legislative Assembly and ending on the date of*
10 *adjournment sine die of the next regular session of the Legislative Assembly*] **new or increased fees**
11 **adopted by a state agency:**

12 (a) Are not effective for agencies in the executive department of government unless approved
13 in writing by the Director of the Oregon Department of Administrative Services;

14 (b) Are not effective for agencies in the judicial department of government unless approved in
15 writing by the Chief Justice of the Supreme Court;

16 (c) Are not effective for agencies in the legislative department of government unless approved
17 in writing by the President of the Senate and the Speaker of the House of Representatives;

18 (d) Shall be reported by the state agency to the Oregon Department of Administrative Services
19 within 10 days of their adoption; and

20 [*e*] *Are rescinded on adjournment sine die of the next regular session of the Legislative Assembly*
21 *as described in this subsection, unless otherwise authorized by enabling legislation setting forth the*
22 *approved fees.*

23 (e) **Are not effective unless authorized by the Legislative Assembly by enabling legislation**
24 **setting forth the approved fees.**

25 (2) **Fees or fee increases authorized by the Legislative Assembly under subsection (1) of**
26 **this section take effect on the effective date of the enabling legislation or on the date spec-**
27 **ified in the rule adopting the fee or fee increase, whichever is later.**

28 [(2)] (3) This section does not apply to:

20 **SECTION 3. The amendments to ORS 291.055 by section 2 of this 2015 Act become oper-**
 21 **ative July 1, 2017.**

22 **SECTION 4. The amendments to ORS 291.055 by sections 1 and 2 of this 2015 Act apply**
 23 **to fees adopted or increased on or after the effective date of this 2015 Act.**

24 **SECTION 5.** Section 41, chapter 698, Oregon Laws 2013, is amended to read:

25 **Sec. 41.** (1) Sections 1, 2, 4 and 4a, **chapter 698, Oregon Laws 2013**, [of this 2013 Act] and the
 26 amendments to statutes and session law by sections 5 to 20, 22 to 25 and 39, **chapter 698, Oregon**
 27 **Laws 2013**, [of this 2013 Act] become operative January 1, 2014.

28 (2) Section 26, **chapter 698, Oregon Laws 2013**, [of this 2013 Act] and the amendments to stat-
 29 utes by sections 29 to 33, [and] 35, [to] **37 and 38, chapter 698, Oregon Laws 2013**, [of this 2013
 30 Act] become operative July 1, 2017.

31 (3) The amendments to ORS 743.748 by section 21, **chapter 698, Oregon Laws 2013**, [of this 2013
 32 Act] become operative April 2, 2014.

33 **SECTION 6. This 2015 Act being necessary for the immediate preservation of the public**
 34 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
 35 **on its passage.**
