PLEASE VOTE 'NO' ON SB 567

SB 567 is a bill that would reduce available resources for vital services, without regard to the state of Oregon's economy at the time. It will not, however, reduce volatility of our tax system.

The bill would sequester and reserve a portion of tax revenues from capital gains based on a mathematical formula that has no predictive value and no tie to existing or forecasted economic performance, and because of this, could be ill-timed, making budgeting even more difficult than it is now.

By looking in the rearview mirror at past performance of capital gains volatility, the contention of proponents is that some sort of pattern may be discerned that would indicate a need to sock away resources for the inevitable rainy day. We agree that responsible reserving is essential to blunt the painful impact of economic cycles, but we do not see this method and automatic capture of tax revenue from capital gains as the right approach.

It is impossible to predict when an owner of capital may sell shares of stock or valuable property, and the look-back provision cannot serve this purpose.

According to Legislative Counsel, this bill will not change the method for determining the kicker, so for those who had hoped otherwise, this bill is no remedy.

We fail to see how this bill contributes meaningfully to Oregon's current reserving programs. Given that this legislature cannot bind future legislatures, the bill, if passed, could theoretically be overridden by a simple majority vote of each chamber, but why force such a future fight? It very well may be the case that when the estimated \$42 million or more in funds are first locked away (in 2019), that your future colleagues will rue the day this bill automatically sweeps the funds from the table.

Instead, we urge you to vote no on SB 567. Thank you for your consideration.
