In memoriam: David Michael Jones, M.P.A.S., PA-C, 1945-2015.

**ISSUES DISCUSSED:**

**BACKGROUND:**

On January 23, 2015, Dave Jones, a pillar of the Condon community passed away. Mr. Jones will be remembered as a trusted advisor and friend, a dedicated educator and ambassador, an advocate and a devoted husband, father, grandfather and uncle.

Born on October 31, 1945 in Seattle, Washington, Jones earned a bachelor's degree in history in 1968 and a second bachelor's degree in zoology in 1970, both from the University of Washington (U of W). In 1975, he joined the ninth class of students at the MEDEX Northwest Physician Assistant Program at the U of W in the early days of the physician assistant profession and became certified as a physician assistant in 1976.

After graduation, Jones moved to Condon, Oregon where he served as one of only two providers of medical care in Gilliam County and was among the first physician assistants in Oregon to practice with remote supervision and receive independent prescription-writing authority. Active in the development of his profession, he served as President of the Oregon Society of Physician Assistants (OSPA), served on the OSPA Board of Directors, served as a member of the Legislative Committee of OSPA, advocated on behalf of physician assistants in support of legislation to optimize the practices of physician assistants and served as a member of the Physician Assistant Committee of the Oregon Medical Board.

Mr. Jones's service and commitment to delivery of health care in rural communities was recognized with several awards including: Rural Physician Assistant of the Year by the American Academy of Physician Assistants in 1988, award for Outstanding Contributions to Rural Health in 2008 from the Office of Rural Health and the Karen Whitaker Knapp Service Award.

Mr. Jones is survived by his wife, Karen Jones, his son and daughter-in-law, Tucker and Stacy Jones, his grandsons, Rowan and Harris Jones, his sister and brother-in-law, Patricia and Duane Rencken, and many nieces and nephews, as well as his many physician assistant colleagues across this state.
