Local Government Mandate:

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

Analysis:

The bill establishes the Oregon Center of Cyber-Excellence and appropriates \$2,500,654 General Fund to the Department of Consumer and Business Services for the project. An in-depth evaluation of the project budget will need to be conducted to determine if the appropriation amount is adequate. Additionally, under current law (ORS 182.122) the Department of Administrative Services has responsibility for and authority over information systems security in the executive branch; this role may require additional analysis as it relates to the bill. A total of 13 positions (9.30 FTE) have been recommended for the project (see table below). This fiscal impact statement has been revised to include position and FTE estimates.
