Revenue Summary

The Oregon State Board of Nursing (Nursing Board) is supported solely by Other Funds revenues generated primarily from examination, licensing and renewal application fees charged to nurses and nursing assistants. Senate Bill 72 increases the examination and license renewal fees for registered nurses and licensed practical nurses by \$9.00 to raise approximately \$500,000 Other Funds per biennium.

Summary of Human Services Subcommittee Action

Board Operations – 001

Senate Bill 72 directs the Nursing Board to increase examination and license renewal fees for registered nurses and licensed practical nurses by \$9.00. These fees are directed to be deposited into the Oregon Nursing Advancement Fund (Fund) established by the bill.

The Subcommittee approved a \$500,000 Other Funds expenditure limitation for the Oregon State Board of Nursing to transfer the principal balance of the Fund to the Oregon Center for Nursing, an Oregon nonprofit that supports the advancement of the nursing profession in Oregon. The annual transfers are estimated to be approximately \$250,000. The Oregon Center for Nursing is a nonprofit organization established in 2002, which collects data and analysis on nurses, collaborates with organizations to address nursing needs, provides education, aims to retain and attract nurses to the profession, and advocates on behalf of nurses.
