# **Summary of General Government Subcommittee Action**

#### Office of the Governor

House Bill 2270 creates the office of the State Resilience Officer within the Office of the Governor to direct, implement and coordinate seismic safety and resilience goal setting and state agency planning and preparation for this purpose. The Legislative and Judicial branches will identify an individual to monitor the effectiveness of seismic safety and resilience planning for their respective branches. The bill appropriates \$304,653 General Fund and establishes two permanent positions (1.50 FTE) to begin on January 1, 2016.
