## **Revenue Summary**

House Bill 3089 appropriates \$25,000 General Fund to the Oregon Department of Geology and Mineral Industries (DOGAMI) to carry out the provisions of the bill. This funding is one-time and will be phased out in the 2017-19 biennial budget.

## **Summary of Capital Construction Subcommittee Action**

House Bill 3089 directs DOGAMI to conduct a study of the mineral resource potential in eastern and southern Oregon counties, and to present the results of the study to the interim legislative committee responsible for the environment and natural resources on or before September 15, 2016. The agency is also directed to post the report on their website.

The bill provides one time funding of \$25,000 General Fund to be used to conduct and report on the study of mineral resources.
