Revenue Summary

House Bill 3402 increases Other Funds expenditure limitation for the Oregon Department of Transportation by \$735,000 from the State Highway Fund to implement the provisions of the bill.

Summary of Transportation and Economic Development Subcommittee Action

House Bill 3402 increases the speed limit for passenger vehicles and certain other vehicles on segments of Interstate 84, Highway 95, Highway 20, Highway 197, Highway 198, Highway 31, Highway 395, Route 205 and Highway 26. The measure exempts portions of Highway 95, Highway 20 and Highway 197 that fall inside of city limits.

<u>Maintenance</u>

The Subcommittee approved a one-time Other Funds expenditure limitation increase of \$735,000 to ODOT to replace signage for highway speeds related to the changes in the bill and to conduct speed studies on certain road segments.
