

House Bill 2027

Sponsored by COMMITTEE ON HEALTH CARE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires metrics and scoring committee of Oregon Health Authority to adopt at least two outcome and quality measures for oral health care provided by coordinated care organizations.

A BILL FOR AN ACT

2 Relating to quality measures for oral health care provided by coordinated care organizations;
3 amending ORS 414.638.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 414.638 is amended to read:

6 414.638. (1) There is created a nine-member metrics and scoring committee appointed by the
7 Director of the Oregon Health Authority. The members of the committee serve two-year terms and
8 must include:

9 (a) Three members at large;

10 (b) Three individuals with expertise in health outcomes measures; and

11 (c) Three representatives of coordinated care organizations.

12 (2) The committee shall use a public process to identify objective outcome and quality measures,
13 including measures of outcome and quality for ambulatory care, inpatient care, chemical dependency
14 and mental health treatment, oral health care and all other health services provided by coordinated
15 care organizations. Quality measures adopted by the committee must be consistent with existing
16 state and national quality measures. The Oregon Health Authority shall incorporate these measures
17 into coordinated care organization contracts to hold the organizations accountable for performance
18 and customer satisfaction requirements.

19 (3) The committee must adopt outcome and quality measures annually and adjust the measures
20 to reflect:

21 (a) The amount of the global budget for a coordinated care organization;

22 (b) Changes in membership of the organization;

23 (c) The organization's costs for implementing outcome and quality measures; and

24 (d) The community health assessment and the costs of the community health assessment con-
25 ducted by the organization under ORS 414.627.

26 **(4) The outcome and quality measures adopted by the committee must include at least**
27 **two measures for oral health care.**

28 [(4)] (5) The authority shall evaluate on a regular and ongoing basis the outcome and quality
29 measures adopted by the committee under this section for members in each coordinated care or-
30 ganization and for members statewide.

31 [(5)] (6) The authority shall utilize available data systems for reporting outcome and quality

3 [(6)] (7) The authority shall publish the information collected under this section at aggregate
4 levels that do not disclose information otherwise protected by law. The information published must
5 report, by coordinated care organization:

6 (a) Quality measures;

7 (b) Costs;

8 (c) Outcomes; and

9 (d) Other information, as specified by the contract between the coordinated care organization
10 and the authority, that is necessary for the authority, members and the public to evaluate the value
11 of health services delivered by a coordinated care organization.
