

House Bill 2206

Sponsored by Representatives TAYLOR, HUFFMAN (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Renames crime of patronizing a prostitute to commercial sexual solicitation.

A BILL FOR AN ACT

Relating to commercial sexual solicitation; amending ORS 12.117, 90.396, 105.555, 131.602, 163.413, 167.008 and 419B.005.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 167.008 is amended to read:

167.008. (1) A person commits the crime of [*patronizing a prostitute*] **commercial sexual solicitation** if the person pays, or offers or agrees to pay, a fee to engage in sexual conduct or sexual contact.

(2) [*Patronizing a prostitute*] **Commercial sexual solicitation** is a Class A misdemeanor.

SECTION 2. ORS 12.117 is amended to read:

12.117. (1) Notwithstanding ORS 12.110, 12.115 or 12.160, an action based on conduct that constitutes child abuse or conduct knowingly allowing, permitting or encouraging child abuse that occurs while the person is under 18 years of age must be commenced before the person attains 40 years of age, or if the person has not discovered the causal connection between the injury and the child abuse, nor in the exercise of reasonable care should have discovered the causal connection between the injury and the child abuse, not more than five years from the date the person discovers or in the exercise of reasonable care should have discovered the causal connection between the child abuse and the injury, whichever period is longer.

(2) As used in subsection (1) of this section, "child abuse" means any of the following:

(a) Intentional conduct by an adult that results in:

(A) Any physical injury to a child; or

(B) Any mental injury to a child which results in observable and substantial impairment of the child's mental or psychological ability to function caused by cruelty to the child, with due regard to the culture of the child;

(b) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual penetration and incest, as those acts are defined in ORS chapter 163;

(c) Sexual abuse, as defined in ORS chapter 163, when the victim is a child; or

(d) Sexual exploitation of a child, including but not limited to:

(A) Conduct constituting violation of ORS 163.435 and any other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage in the performing for people to observe or the photographing, filming, tape recording or other exhibition which, in whole or in part, depicts sexual conduct or contact; and

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (B) Allowing, permitting, encouraging or hiring a child to engage in prostitution or [to patronize
2 a prostitute] **commercial sexual solicitation**, as defined in ORS chapter 167.

3 (3) Nothing in this section creates a new cause of action or enlarges any existing cause of
4 action.

5 **SECTION 3.** ORS 90.396 is amended to read:

6 90.396. (1) Except as provided in subsection (2) of this section, after at least 24 hours' written
7 notice specifying the acts and omissions constituting the cause and specifying the date and time of
8 the termination, the landlord may terminate the rental agreement and take possession as provided
9 in ORS 105.105 to 105.168, if:

10 (a) The tenant, someone in the tenant's control or the tenant's pet seriously threatens to inflict
11 substantial personal injury, or inflicts any substantial personal injury, upon a person on the prem-
12 ises other than the tenant;

13 (b) The tenant or someone in the tenant's control recklessly endangers a person on the premises
14 other than the tenant by creating a serious risk of substantial personal injury;

15 (c) The tenant, someone in the tenant's control or the tenant's pet inflicts any substantial per-
16 sonal injury upon a neighbor living in the immediate vicinity of the premises;

17 (d) The tenant or someone in the tenant's control intentionally inflicts any substantial damage
18 to the premises or the tenant's pet inflicts substantial damage to the premises on more than one
19 occasion;

20 (e)(A) The tenant intentionally provided substantial false information on the application for the
21 tenancy within the past year;

22 (B) The false information was with regard to a criminal conviction of the tenant that would have
23 been material to the landlord's acceptance of the application; and

24 (C) The landlord terminates the rental agreement within 30 days after discovering the falsity
25 of the information; or

26 (f) The tenant, someone in the tenant's control or the tenant's pet commits any act that is out-
27 rageous in the extreme, on the premises or in the immediate vicinity of the premises. For purposes
28 of this paragraph, an act is outrageous in the extreme if the act is not described in paragraphs (a)
29 to (e) of this subsection, but is similar in degree and is one that a reasonable person in that com-
30 munity would consider to be so offensive as to warrant termination of the tenancy within 24 hours,
31 considering the seriousness of the act or the risk to others. An act that is outrageous in the extreme
32 is more extreme or serious than an act that warrants a 30-day termination under ORS 90.392. Acts
33 that are "outrageous in the extreme" include, but are not limited to, the following acts by a person:

34 (A) Prostitution, [patronizing a prostitute] **commercial sexual solicitation** or promoting
35 prostitution, as described in ORS 167.007, 167.008 and 167.012;

36 (B) Manufacture, delivery or possession of a controlled substance, as described in ORS 475.005,
37 but not including:

38 (i) The medical use of marijuana in compliance with ORS 475.300 to 475.346;

39 (ii) Possession of, or delivery for no consideration of, less than one avoirdupois ounce of
40 marijuana as described in ORS 475.860 (3) or 475.864 (3); or

41 (iii) Possession of prescription drugs;

42 (C) Intimidation, as described in ORS 166.155 and 166.165; or

43 (D) Burglary as described in ORS 164.215 and 164.225.

44 (2) If the cause for a termination notice given pursuant to subsection (1) of this section is based
45 upon the acts of the tenant's pet, the tenant may cure the cause and avoid termination of the

1 tenancy by removing the pet from the premises prior to the end of the notice period. The notice
 2 must describe the right of the tenant to cure the cause. If the tenant returns the pet to the premises
 3 at any time after having cured the violation, the landlord, after at least 24 hours' written notice
 4 specifying the subsequent presence of the offending pet, may terminate the rental agreement and
 5 take possession as provided in ORS 105.105 to 105.168. The tenant does not have a right to cure this
 6 subsequent violation.

7 (3) For purposes of subsection (1) of this section, someone is in the tenant's control if that per-
 8 son enters or remains on the premises with the tenant's permission or consent after the tenant
 9 reasonably knows or should know of that person's act or likelihood to commit any act of the type
 10 described in subsection (1) of this section.

11 (4) An act can be proven to be outrageous in the extreme even if the act is one that does not
 12 violate a criminal statute. Notwithstanding the references to criminal statutes in subsection (1)(f)
 13 of this section, the landlord's burden of proof in an action for possession under subsection (1) of this
 14 section is the civil standard of proof by a preponderance of the evidence.

15 (5) If a good faith effort by a landlord to terminate the tenancy under subsection (1)(f) of this
 16 section and to recover possession of the rental unit under ORS 105.105 to 105.168 fails by decision
 17 of the court, the landlord may not be found in violation of any state statute or local ordinance re-
 18 quiring the landlord to remove that tenant upon threat of fine, abatement or forfeiture as long as
 19 the landlord continues to make a good faith effort to terminate the tenancy.

21 105.555. (1) The following are declared to be nuisances and shall be enjoined and abated as

 28 wherein take place any of the acts or wherein are kept, stored or located any of the games, devices
 29 or things that are forbidden by or made punishable by ORS 167.108 to 167.164;

30 (c) Any place that has been determined to be not fit for use under ORS 453.876 and that has
 31 not been decontaminated and certified as fit for use under ORS 453.885 within 180 days after the
 32 determination under ORS 453.876; and

33 (d) Any place where activity involving the unauthorized delivery, manufacture or possession of
 34 a controlled substance, as defined in ORS 475.005, occurs or any place wherein are kept, stored or
 35 located any of the devices, equipment, things or substances used for unauthorized delivery, manu-
 36 facture or possession of a controlled substance. As used in this paragraph, "devices, equipment,
 37 things" does not include hypodermic syringes or needles. This paragraph does not apply to acts that
 38 constitute violations under ORS 475.860 or 475.864.

39 (2) Nothing in ORS 105.550 to 105.600, 166.715 and 167.158 applies to property to the extent that
 40 the devices, equipment, things or substances that are used for delivery, manufacture or possession
 41 of a controlled substance are kept, stored or located in or on the property for the purpose of lawful
 42 sale or use of these items.

24 offers or agrees to pay, a fee to engage in sexual intercourse or sexual contact with a minor.

25 (2)(a) If the person does not have a prior conviction under this section at the time of the offense,
26 purchasing sex with a minor is a Class C felony and the person may use a defense described in ORS
27 163.325 only if the minor was at least 16 years of age.

28 (b) If the person has one or more prior convictions under this section at the time of the offense,
29 purchasing sex with a minor is a Class B felony, the state need not prove that the person knew the
30 minor was under 18 years of age and the person may not use a defense described in ORS 163.325.

31 (3)(a) When a person is convicted under this section, in addition to any other sentence that may
32 be imposed, the court shall impose and may not suspend the sentence described in paragraph (b) of
33 this subsection.

34 (b) The mandatory minimum sentences that apply to paragraph (a) of this subsection are as fol-
35 lows:

36 (A) For a person's first conviction, a fine in the amount of \$10,000, a term of incarceration of
37 at least 30 days and completion of a john school program.

38 (B) For a person's second or subsequent conviction, a fine in the amount of \$20,000 and the
39 court shall designate the offense as a sex crime under ORS 181.805.

40 (c) Notwithstanding paragraphs (a) and (b) of this subsection, if the court determines that the
41 person is unable to pay the full amount of the mandatory minimum fine, the court shall impose and
42 may not suspend a fine in an amount the court determines the person is able to pay.

43 (d) For a person's first conviction under this section, the court may designate the offense as a
44 sex crime under ORS 181.805 if the court finds that the circumstances of the offense and the age
45 of the minor as reported to the defendant require the defendant to register and report as a sex

1 offender for the safety of the community.

2 (4) As used in this section:

3 (a) “John school” means any course, class or program intended to educate and prevent
 4 recidivism of persons who have been arrested for, charged with or convicted of [*patronizing a*
 5 *prostitute*] **commercial sexual solicitation** or purchasing sex with a minor or attempting to [*pa-*
 6 *tronize a prostitute*] **engage in commercial sexual solicitation** or purchase sex with a minor.

7 (b) “Minor” means a person under 18 years of age.

8 **SECTION 7.** ORS 419B.005 is amended to read:

9 419B.005. As used in ORS 419B.005 to 419B.050, unless the context requires otherwise:

10 (1)(a) “Abuse” means:

11 (A) Any assault, as defined in ORS chapter 163, of a child and any physical injury to a child
 12 which has been caused by other than accidental means, including any injury which appears to be
 13 at variance with the explanation given of the injury.

14 (B) Any mental injury to a child, which shall include only observable and substantial impairment
 15 of the child’s mental or psychological ability to function caused by cruelty to the child, with due
 16 regard to the culture of the child.

17 (C) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual pene-
 18 tration and incest, as those acts are described in ORS chapter 163.

19 (D) Sexual abuse, as described in ORS chapter 163.

20 (E) Sexual exploitation, including but not limited to:

21 (i) Contributing to the sexual delinquency of a minor, as defined in ORS chapter 163, and any
 22 other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage
 23 in the performing for people to observe or the photographing, filming, tape recording or other ex-
 24 hibition which, in whole or in part, depicts sexual conduct or contact, as defined in ORS 167.002 or
 25 described in ORS 163.665 and 163.670, sexual abuse involving a child or rape of a child, but not in-
 26 cluding any conduct which is part of any investigation conducted pursuant to ORS 419B.020 or
 27 which is designed to serve educational or other legitimate purposes; and

28 (ii) Allowing, permitting, encouraging or hiring a child to engage in prostitution as described in
 29 ORS 167.007 or a commercial sex act as defined in ORS 163.266, to purchase sex with a minor as
 30 described in ORS 163.413 or [*to patronize a prostitute*] **to engage in commercial sexual solicitation**
 31 as described in ORS 167.008.

32 (F) Negligent treatment or maltreatment of a child, including but not limited to the failure to
 33 provide adequate food, clothing, shelter or medical care that is likely to endanger the health or
 34 welfare of the child.

35 (G) Threatened harm to a child, which means subjecting a child to a substantial risk of harm
 36 to the child’s health or welfare.

37 (H) Buying or selling a person under 18 years of age as described in ORS 163.537.

38 (I) Permitting a person under 18 years of age to enter or remain in or upon premises where
 39 methamphetamines are being manufactured.

40 (J) Unlawful exposure to a controlled substance, as defined in ORS 475.005, that subjects a child
 41 to a substantial risk of harm to the child’s health or safety.

42 (b) “Abuse” does not include reasonable discipline unless the discipline results in one of the
 43 conditions described in paragraph (a) of this subsection.

44 (2) “Child” means an unmarried person who is under 18 years of age.

19 Division, Youth Development Division, Office of Child Care, the Oregon Youth Authority, a county
20 health department, a community mental health program, a community developmental disabilities
21 program, a county juvenile department, a licensed child-caring agency or an alcohol and drug
22 treatment program.

45 (aa) Employee of a private agency or organization facilitating the provision of respite services,

3 (bb) Employee of a public or private organization providing child-related services or activities:
