House Bill 2224

Sponsored by Representative HOYLE (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Department of Human Services to adopt rules for licensing of stabilization and crisis units that house persons with developmental disabilities. Specifies criteria.

Creates Office of Investigations in Department of Justice to conduct investigations and report on allegations of abuse committed against persons who are elderly or who have disabilities. Transfers responsibilities for abuse investigations involving persons who are elderly or have disabilities from Department of Human Services to office.

Declares emergency, effective on passage.

9	Be It Enacted by the People of the State of Oregon:
10	SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS 443.400 to
11	443.455.
12	SECTION 2. (1) The Department of Human Services shall adopt rules for the licensing
13	of residential training homes and facilities that house individuals who have been found by a
14	court to have intellectual disabilities and to be in need of commitment for residential care,
15	treatment and training under ORS 427.290. The rules must do all of the following:
16	(a) Create a separate license classification for homes and facilities that house individuals
17	who exhibit violent or excessively aggressive behaviors to ensure that such homes and fa-
18	cilities offer adequate levels of security and staffing and have sufficient staff qualified to
19	address the needs of such residents.
20	(b) Require that each home or facility have an emergency preparedness plan and meet
21	minimum security, health and safety standards.
22	(c) Set minimum training standards for the staff of homes and facilities.
23	(d) Except as provided under paragraph (f) of this subsection, require at least 40 hours
24	of training for the staff of homes and facilities on how to handle safety concerns and resident
25	needs that arise in any of the following situations:
26	(A) Taking a resident to a retail establishment that predominantly sells pornography or
27	objects designed for sexual stimulation or gratification.
28	(B) Assisting a resident in purchasing pornography or objects designed for sexual stim-

1 ulation or gratification.

2 (C) Cleaning objects before or after their use by a resident for sexual stimulation or 3 gratification.

4 (D) Observing a resident masturbating, viewing pornography or using an object for the 5 purpose of sexual stimulation or gratification.

6 (e) Require homes and facilities to pay additional compensation to employees that un-7 dergo the training and assist residents in one or more of the activities described in para-8 graph (d) of this subsection.

9 (f) Require the accommodation of staff who express religious, moral or safety objections 10 to the activities described in paragraph (d) of this subsection, including objections based on 11 concern that a resident may become violent or sexually aggressive with the staff member 12 and concern that exposure to the activities could endanger the staff member's emotional 13 well-being.

(g) Prohibit homes and facilities from disciplining or taking other negative employment
 action toward a staff member who expresses any objection under paragraph (f) of this sub section.

(h) Create at least three teams of staff qualified to respond to elevated incidents of violence and assist the homes and facilities to restore stability following a violent incident. The teams must be located in the Portland, Salem and Eugene areas and any other areas where homes or facilities described in paragraph (a) of this subsection are located. The teams must also be available to provide back-up staffing for all such homes and facilities. The teams must include at least one psychiatrist and one physical therapist and may include other health care providers designated by the department.

(2) The state hospital located in Junction City must reserve 10 beds as follows:

(a) Five beds for individuals who, due to their tendency toward violent behavior, can no
 longer be safely cared for in a home or facility licensed under this section; and

(b) Five beds for individuals who are in a severe crisis and require assessment and
transition services before returning to a home or facility described in paragraph (a) of this
subsection.

<u>SECTION 3.</u> (1) The Office of Investigations in created within the Department of Justice.
 (2) The office is responsible for conducting investigations under ORS 124.070, 430.735 to
 430.765, 441.630 to 441.680 and section 5 of this 2015 Act concerning abuse alleged to have been
 committed against a person who is elderly or disabled and for preparing reports maintained
 under ORS 124.085, 430.757, section 4, chapter 104, Oregon Laws 2014, and section 11 of this
 2015 Act.

(3) The office shall be under the supervision and control of an administrator who is re sponsible for the performance of the duties, functions and powers of the office.

(4) The Attorney General shall appoint the administrator, who holds office at the pleas ure of the Attorney General.

40 (5) The administrator shall be paid a salary as provided by law or, if not so provided, as
 41 prescribed by the Attorney General.

42 (6) For purposes of administration, subject to the approval of the Attorney General, the
43 administrator may organize and reorganize the office as the administrator considers neces44 sary to properly conduct the work of the office.

45 (7) The administrator may divide the functions of the office into administrative divisions.

1 Subject to the approval of the Attorney General, the administrator may appoint an individual

2 to manage each division. The manager of each division serves at the pleasure of the admin-

istrator and is not subject to the provisions of ORS chapter 240. Each manager appointed
under this subsection must be well qualified by technical training and experience in the

13 <u>SECTION 5.</u> (1) The Office of Investigations shall immediately begin an investigation 14 upon receipt of a report under ORS 441.640 and 441.645 or a complaint of any person con-15 cerning a long term care facility, a residential facility or an adult foster home:

(a) That a resident has been injured, abused or neglected; or

(b) That there exists circumstances that could place a resident's health or safety in im minent danger.

19 (2) Not later than 60 days after receipt of a report or complaint, the office shall complete the investigation and shall prepare a written letter of determination that states the office's 20findings concerning each incident or problem alleged in the complaint. The office shall de-2122termine whether the alleged incident or problem was substantiated or unsubstantiated, or 23whether the office was unable to substantiate the alleged incident or problem. The Attorney General shall adopt by rule definitions for the terms "substantiated," "unsubstantiated" and 24 25"unable to substantiate." If abuse is substantiated, the letter of determination shall state whether the facility or home or an individual, or both, was responsible. The Attorney General 2627shall adopt by rule criteria for determining responsibility for substantiated abuse.

(3) A copy of the letter of determination shall be placed in the facility's or home's complaint file. Copies shall be sent to the facility or home and the complainant. The facility or home and the complainant receiving the letter of determination shall be given 10 days to respond with additional information and shall be informed of the appeals process.

(4) If the office determines that an individual who holds a license or certificate for a health occupation is directly responsible for the abuse, the office shall send a copy of its letter of determination and investigation report to the state agency responsible for licensing or certifying the individual in the health occupation. If the individual identified under this section is a nursing assistant, the office shall give the nursing assistant 10 days to respond with additional information. The office also shall notify by mail the nursing assistant implicated in the investigation. The notification shall include a description of:

40 (b) The date and time of occurrence;

41 (c) The right to a contested case hearing conducted in accordance with ORS chapter 183;

(d) The office's obligation under subsection (6) of this section to report the substantiated

(1) As used in this section: (a) "Negative outcome" includes serious injury, rape, sexual abuse or death. 10 (b) "Rape" means rape in the first, second or third degree as described in ORS 163.355, 11 12163.365 and 163.375. 13 (c) "Serious injury" means physical injury that creates a substantial risk of death or that causes serious and protracted disfigurement, protracted impairment of health or protracted 14 15 loss or impairment of the function of any bodily organ. (d) "Sexual abuse" means any form of sexual contact between an employee of a long term 16 care facility, residential facility or adult foster home or a person providing services in the 17 facility or home and a resident of that facility or home, including but not limited to sodomy, 18 sexual coercion, sexually explicit photographing and sexual harassment. 19 (2) If the Office of Investigations makes a finding of abuse arising from deliberate or 20other than accidental action or inaction that is likely to cause a negative outcome by a per-21 22son with a duty of care toward a resident of a facility or home: 23(a) The office shall immediately notify the agency responsible for licensing the facility 24 or home; and (b) The office may impose a civil penalty of not more than \$1,000 per occurrence. 25(3) If the abuse resulted in the death, serious injury, rape or sexual abuse of a resident, 2627the department shall impose a civil penalty of not less than \$2,500 for each occurrence of substantiated abuse, not to exceed \$15,000 in any 90-day period, for a long term care facility 28or a residential facility. 2930 (4) A civil penalty under this section shall be imposed in the manner provided by ORS 31 183.745. (5) All penalties recovered under this section shall be paid into the Long Term Care 32Ombudsman Account established in ORS 441.153. 33 34 SECTION 7. In adopting criteria for imposing civil penalties on a long term care facility, 35residential facility or adult foster home under section 6 of this 2015 Act, the Office of In-36 vestigations shall consider: 37 (1) Any prior violations of laws or rules pertaining to facilities or homes; 38 (2) The financial benefits, if any, realized by the facility or home as a result of the violation; 39 (3) The gravity of the violation, including the actual or potential threat to the health, 40 safety and well-being of one or more residents; 41 (4) The severity of the actual or potential harm caused by the violation; and 42 (5) The facility's past history of correcting violations and preventing the recurrence of 43 violations. 44

45 SECTION 8. The administrator of the Office of Investigations and authorized represen-

2 compel the attendance of witnesses and the production of documents or other written information necessary to carry out the provisions of sections 5 to 12 of this 2015 Act. If any 3 person fails to comply with a subpoena issued under this section or refuses to testify on 4 matters on which the person lawfully may be interrogated, the administrator or authorized 5 representative may follow the procedure set out in ORS 183.440 to compel obedience. 6 SECTION 9. (1) The Office of Investigations, the Department of Human Services and the 7 Oregon Health Authority may share confidential or protected health information with re-8 9 spect to recipients of public assistance or medical assistance as necessary for: (a) The investigation and prosecution of abuse of a person who is elderly or who has a 10

(2) Disclosure of confidential or protected health information under this section must be
 limited to the minimum amount of information necessary for an agency to carry out the
 agency's duties under law and must be protected from any unauthorized redisclosure.

16 <u>SECTION 10.</u> (1)(a) The owner or operator of a long term care facility, residential facility 17 or adult foster home may not prohibit, discourage or use intimidation against any person to 18 prevent the filing of a complaint with the Office of Investigations.

(b) If a resident of a facility or home, or a person acting on the resident's behalf, files a
complaint with the office, the owner or operator of a facility or home may not retaliate
against the resident by:

22 (A) Increasing charges;

23 (B) Decreasing services, rights or privileges;

24 (C) Threatening to increase charges or decrease services, rights or privileges;

25 (D) Taking or threatening to take any action to coerce or compel the resident to leave 26 the facility or home; or

27 (E) Harassing or abusing or threatening to abuse a resident in any manner.

(c) The owner or operator of a facility or home may not retaliate against any person who
files a complaint or any witness or employee of a facility or home who is interviewed about
the complaint, including but not limited to retaliation by restriction of otherwise lawful access to the facility or home or to any resident thereof, or, if an employee, to dismissal or
harassment.

(2) Anyone participating in good faith in the filing of a complaint pursuant to this section is immune from any liability, civil or criminal, that might otherwise be incurred or imposed with respect to the filing or substance of the complaint. Any such participant shall have the same immunity with respect to participating in any judicial proceeding resulting from the complaint. A person does not act in good faith for the purposes of this subsection if the substance of the complaint is false and:

(a) The person knows that the substance of the complaint is false; or

(b) The person makes the complaint with the intent to harm the facility or home, or the
owner or operator of the facility or home, and the person shows a reckless disregard for the
truth or falsity of the substance of the complaint.

43 <u>SECTION 11.</u> (1) The Office of Investigations shall maintain a proper record of reports 44 under ORS 441.640 and 441.645 on residents in long term care facilities. Each incident of 45 abuse alleged in a report shall be classified as substantiated, unsubstantiated or unable to

1 substantiate, or recorded as under appeal by the facility.

2 (2) All reports shall be cataloged under the name of the long term care facility associated 3 with the complaint.

4 <u>SECTION 12.</u> In accordance with applicable provisions of ORS chapter 183, the Attorney 5 General may adopt rules necessary for the administration of the laws that the Office of In-6 vestigations is charged with administering.

SECTION 13. The duties, functions and powers of the Department of Human Services
 relating to the investigation and reporting of allegations of abuse committed against persons
 who are elderly or who have disabilities are imposed upon, transferred to and vested in the
 Office of Investigations created in section 3 of this 2015 Act.

11 <u>SECTION 14.</u> (1) The Director of Human Services shall:

(a) Deliver to the Office of Investigations all records and property within the jurisdiction
of the director that relate to the duties, functions and powers transferred by section 13 of
this 2015 Act; and

(b) Transfer to the office those employees engaged primarily in the exercise of the duties,
 functions and powers transferred by section 13 of this 2015 Act.

(2) The administrator of the office shall take possession of the records and property, and shall take charge of the employees and employ them in the exercise of the duties, functions and powers transferred by section 13 of this 2015 Act, without reduction of compensation but subject to change or termination of employment or compensation as provided by law.

(3) The Governor shall resolve any dispute between the department and the office relat ing to transfers of records, property and employees under this section, and the Governor's
 decision is final.

<u>SECTION 15.</u> (1) The unexpended balances of amounts authorized to be expended by the Department of Human Services for the biennium beginning July 1, 2015, from revenues dedicated, continuously appropriated, appropriated or otherwise made available for the purpose of administering and enforcing the duties, functions and powers transferred by section 13 of this 2015 Act are transferred to and are available for expenditure by the Office of Investigations for the biennium beginning July 1, 2015, for the purpose of administering and enforcing the duties, functions and powers transferred by section 13 of this 2015 Act.

(2) The expenditure classifications, if any, established by Acts authorizing or limiting
 expenditures by the department remain applicable to expenditures by the office under this
 section.

<u>SECTION 16.</u> The transfer of duties, functions and powers to the Office of Investigations by section 13 of this 2015 Act does not affect any action, proceeding or prosecution involving or with respect to such duties, functions and powers begun before and pending at the time of the transfer, except that the office is substituted for the Department of Human Services in the action, proceeding or prosecution.

39 <u>SECTION 17.</u> (1) Nothing in sections 13 to 16 of this 2015 Act relieves a person of a li-40 ability, duty or obligation accruing under or with respect to the duties, functions and powers 41 transferred by section 13 of this 2015 Act. The Office of Investigations may undertake the 42 collection or enforcement of any such liability, duty or obligation.

(2) The rights and obligations of the Department of Human Services legally incurred un der contracts, leases and business transactions executed, entered into or begun before the
 operative date of section 13 of this 2015 Act accruing under or with respect to the duties,

1 functions and powers transferred by section 13 of this 2015 Act are transferred to the office.

2 For the purpose of succession to these rights and obligations, the office is a continuation of

3 the department and not a new authority.

4 <u>SECTION 18.</u> Notwithstanding the transfer of duties, functions and powers by section 13 5 of this 2015 Act, the rules of the Department of Human Services with respect to such duties, 6 functions or powers that are in effect on the operative date of section 13 of this 2015 Act 7 continue in effect until superseded or repealed by rules of the Office of Investigations. Ref-8 erences in such rules of the department to the department or an officer or employee of the 9 department are considered to be references to the office or an officer or employee of the 10 office.

SECTION 19. Whenever, in any uncodified law or resolution of the Legislative Assembly 11 12or in any rule, document, record or proceeding authorized by the Legislative Assembly, in the context of the duties, functions and powers transferred by section 13 of this 2015 Act, 13 reference is made to the Department of Human Services, or an officer or employee of the 14 15 department, whose duties, functions or powers are transferred by section 13 of this 2015 Act, 16 the reference is considered to be a reference to the Office of Investigations or an officer or employee of the office who by this 2015 Act is charged with carrying out such duties, func-17 18 tions and powers.

19 <u>SECTION 20.</u> The administrator of the Office of Investigations may be appointed before 20 the operative date of section 13 of this 2015 Act and may take any action before that date 21 that is necessary to enable the administrator to exercise, on and after the operative date of 22 section 13 of this 2015 Act, the duties, functions and powers of the administrator pursuant 23 to section 13 of this 2015 Act.
